**A PROCLAMATION.**

In exercise of the powers vested in me by section 17 of the Village Authorities Laws, 1931 to (No. 2) 1937, and otherwise, I, Roland Evelyn Turnbull, Companion of the Most Distinguished Order of Saint Michael and Saint George, Acting Governor and Commander-in-Chief in and over the Colony of Cyprus, do hereby order and proclaim that from and after the 2nd day of December, 1948:—

(1) The boundary of the Town of Famagusta and Varosha shall be as set forth in Schedule A hereof;

(2) The Town of Famagusta and Varosha comprised within the boundary aforesaid shall be divided into the quarters set forth in Schedule B hereof;

(3) All previous Proclamations relating to the boundary and quarters of the Town of Famagusta and Varosha are hereby revoked with effect from the 2nd day of December, 1948.

**SCHEDULE A.**

*Boundary of the Town of Famagusta and Varosha.*

The boundary commences at the most northern point of plot No. 111 of the Government Survey Plan No. XXIV.51.E, locality "Karaolos", which point is on the seashore, and proceeds south-eastwards along the seashore (but including all the islands off the seashore) to the mouth of the stream which is the southern boundary of plot No. 192 of the Government Survey Plan No. XXXIII.30.4.III, locality "Limnara"; thence south-westwards up the said stream to the most eastern point of plot No. 197 of the said plan, locality "Dhromos tou Xenti"; thence south-westwards and north-westwards along a road to the junction of roads at the most eastern corner of plot No. 199 of the Government Survey Plan No. XXXIII.29.6.IV, locality "Exintara"; thence south-westwards along a road to the most southern point of plot No. 209 of the Government Survey Plan No. XXXIII.37.3.I, locality "Beylitika", which point is on the aqueduct; thence north-westwards along the aqueduct to the road at the southern boundary of plot No. 60 of the Government Survey Plan No. XXXIII.29.2.III, on which stands Ayios Memnon Church; thence south-westwards along the said road to its junction with the main road from the village of Dherinia to Varosha Town, which junction is at the most southern point of plot No. 41 of the Government Survey Plan No. XXXIII.29.4.I, locality "Tekkelitika";

thence north-westwards along the said main road to the most southern point of plot No. 42 of the Government Survey Plan No. XXXIII.28.E; thence westwards along another road, leading to the village of Phrenaros, to the junction of roads at the south-western corner of plot No. 23 of the Government Survey Plan No. XXXIII.28.W.2, locality "Dhyo Loutsia"; thence northwards along another road, leading to Varosha Town, to the most eastern point of plot No. 276 of the Government Survey Plan No. XXXIII.28.W; thence north-westwards along the boundaries of and including plots Nos. 276, 180, 232 and 238 of the said plan to the most western point of the last mentioned plot, which point is on the stream "Pharankas"; thence south-westwards up the said stream to the most southern point of plot No. 195 of the said plan, locality "Kremni"; thence north-westwards along the boundaries of and including plots Nos. 195 and 196 of the said plan, plots Nos. 243 and 127 of the Government Survey Plan No. XXXIII.27.E, locality "Ayios Yeoryios tou Pharankou", plots Nos. 212, 207 and 260 of the Government Survey Plan No. XXXIII.19.E, to the most western point of the last mentioned plot, locality "Kamini tou Kiayia", which point is on a road; thence south-westwards along the said road to the most western point of plot No. 1 of the Government Survey Plan No. XXXIII.19.W, which point is on the main road from Larnaca Town to Famagusta Town; thence south-westwards along the said main road to the most southern point of plot No. 279 of the said plan, locality "Strovilia"; thence northwards along another road, leading to the village of Kalopsidha, to the most eastern point of plot No. 381 of the Government Survey Plan No. XXXIII.18.E, locality "Verou"; thence south-westwards and northwards along the boundaries of and including plots Nos. 381, 250, 366 and 103 of the said plan, plots Nos. 102, 101, 100, 99, 364, 98, 90, 89, 88, 4, 3, 429, 428 and 1 of the Government Survey Plan No. XXXIII.10.E, to the most western point of the last mentioned plot, which point is on a road adjoining the stream "Ayios Mamas"; thence north-westwards along the said stream to the north-western corner of plot No. 7 of the Government Survey Plan No. XXIV.58.W; thence north-eastwards along the boundaries of and including plots Nos. 7, 3, 1, 2, locality "Moutti tis Khalis", 6 and 15 of the said plan, plots Nos. 134, 17, 21, 24, 22, 23, 24, 25, 67 (crossing the Cyprus Government Railway), 27, 28, 29, 30 and 31, of the Government Survey Plan No. XXIV.58.E, plots Nos. 32, 33, 34 and 35 of the Government Survey Plan No. XXIV.59.W, to the north-eastern corner of the last mentioned plot, which corner is on a water-channel; thence north-westwards along the said channel to the north-western corner of plot No. 12 of the said plan; thence north-eastwards along the boundaries of and including plots Nos. 12, 13, 14, 15, 11, 10 and 139 of the said plan to the most western point of Ayios Yeoryios Church; thence north-eastwards in a straight line, crossing the Karpas-Famagusta main road, to the point at which the water-channel running north-westwards through plot No. 113 of the said plan meets the north-western boundary of the said plot; thence north-eastwards along the said channel to the seashore; thence north-eastwards along the seashore to the point of commencement, all which said boundary is shown hatched in black on the Government Survey Plan Serial No. 1418.

SCHEDULE B.

QUARTERS OF THE TOWN OF FAMAGUSTA AND VAROSHA.

*Famagusta Quarter.*

The boundary commences at the most northern point of plot No. 1 of the Government Survey Plan No. XXXIII.4.5.III, which point is on the seashore, and proceeds south-eastwards along the seashore to the south-eastern corner of plot No. 58 of the Government Survey

Plan No. XXXIII.4.6.III; thence westwards in a straight line, crossing the Famagusta Harbour road, to the most eastern point of plot No. 1 of the Government Survey Plan No. XXXIII.4.5.III, which plot is the moat; thence westwards, northwards and eastwards along the boundary of and including the said plot to the point of commencement.

The boundary also includes the islands "Nisin tou Maymouniou" and "Nisin Megalon", respectively, under plot No. 56 of the Government Survey Plan No. XXXIII.4.6.2, and plot No. 57 of the Government Survey Plan No. XXXIII.5.4.3.

All the area within the said boundary is shown coloured yellow and hatched red on the Government Survey Plan Serial No. 1418.

*Ayios Loukas Quarter.*

The boundary commences at the most western point of plot No. 1 of the Government Survey Plan No. XXXIII.10.E.I, locality "Spilous", which point is on a road adjoining the stream "Ayios Mamas", and proceeds north-westwards along the said stream to the north-western corner of plot No. 7 of the Government Survey Plan No. XXIV.58.W; thence north-eastwards along the boundaries of and including plots Nos. 7, 3, 1, 2, locality "Moutti tis Khalis", 6 and 15 of the said plan, plots Nos. 134, 17, 21, 24, 22, 23, 24, 25, 67 (crossing the Cyprus Government Railway), 27, 28, 29, 30 and 31 of the Government Survey Plan No. XXIV.58.E, plots Nos. 32, 33, 34 and 35 of the Government Survey Plan No. XXIV.59.W, to the north-eastern corner of the last mentioned plot, which corner is on a water-channel; thence north-westwards along the said channel to the north-western corner of plot No. 12 of the said plan; thence north-eastwards along the boundaries of and including plots Nos. 12, 13, 14, 15, 11, 10 and 139 of the said plan to the most western point of Ayios Yeoryios Church; thence north-eastwards in a straight line, crossing the Karpas-Famagusta main road, to the point at which the water-channel running north-westwards through plot No. 113 of the said plan meets the north-western boundary of the said plot; thence north-eastwards along the said channel to the seashore, locality "Karaolos"; thence northwards, eastwards and southwards along the seashore to the most northern point of plot No. 1 of the Government Survey Plan No. XXXIII.4.W.1, which plot is the moat; thence westwards and southwards along the boundary of but excluding the said plot to the north-western corner of plot No. 1 of the Government Survey Plan No. XXXIII.12.2.II, which corner is on a T-road junction; thence south-westwards along the main road, from Larnaca Town to Famagusta Town, to the most southern point of plot No. 279 of the Government Survey Plan No. XXXIII.19.W.2, locality "Strovilia"; thence northwards along another road, leading to the village of Kalopsidha, to the most eastern point of plot No. 381 of the Government Survey Plan No. XXXIII.18.E.1, locality "Verou"; thence south-westwards and northwards along the boundaries of and including plots Nos. 381, 250, 366 and 103 of the said plan, plots Nos. 102, 101, 100, 99, 364, 98, 90, 89, 88, 4, 3, 429, 428 and 1 of the Government Survey Plan No. XXXIII.10.E, to the point of commencement.

All the area within the said boundary is shown coloured red on the Government Survey Plan Serial No. 1418.

*Ayios Nikolaos Quarter.*

The boundary commences at the junction of Demetra Street with the main road from Larnaca Town to Famagusta Town and proceeds north-eastwards along the said main road to the most western point of plot No. 1 of the Government Survey Plan No. XXXIII.12.2.II; thence eastwards along the boundaries of and including plots Nos. 1, 2, 3, 4, 5, 6,

7, 8, 9, 10, 11, 12, 13, 14, 15 and 16 of the said plan, plots Nos. 17, 18, 19, 20, 21, 22, 23, 24, 25, 26, 27, 28 and 29 of the Government Survey Plan No. XXXIII.12.3.I, plots Nos. 30, 31 and 32 of the Government Survey Plan No. XXXIII.4.6.III to the north-eastern corner of the last mentioned plot; thence eastwards in a straight line, crossing the Famagusta Harbour road to the south-eastern corner of plot No. 58 of the said plan, which corner is on the seashore; thence eastwards and southwards along the seashore to the south-eastern corner of plot No. 373 of the Government Survey Plan No. XXXIII.13.4.IV; thence westwards along the boundaries of and including plots Nos. 373 and 372 to the south-western corner of the last mentioned plot; thence westwards along Livadhion Street to its junction with Hecate Street; thence north-westwards along the last mentioned street to its junction with Phaleron Avenue; thence south-westwards along the said avenue to its junction with Theseus Street; thence westwards along the said street to its junction with Athena Street; thence northwards along the last mentioned street to its junction with Miltiades Street; thence westwards along the last mentioned street to its junction with Ayia Paraskevi Street; thence westwards along the last mentioned street to its junction with Demophon Street; thence northwards along the last mentioned street to its junction with Demetra Street; thence north-westwards along the last mentioned street to the point of commencement.

The boundary also includes the islands: plots Nos. 18 ("Nisi tou Jiri") and 21 of the Government Survey Plan No. XXXIII.13.1.I, plots Nos. 29, ("Pnigmenos") 30 and 168 ("Pambouli") of the Government Survey Plan No. XXXIII.13.1.II.

All the area within the said boundary is shown coloured brown on the Government Survey Plan Serial No. 1418.

#### *Ayia Zoni Quarter.*

The boundary commences at the junction of Alcamenes Street with Ayia Paraskevi Street, and proceeds north-eastwards along the last mentioned street to its junction with Miltiades Street; thence eastwards along the last mentioned street to its junction with Athena Street; thence southwards along the last mentioned street to its junction with Theseus Street; thence eastwards along the last mentioned street to its junction with Phaleron Avenue; thence north-eastwards along the said avenue to its junction with Hecate Street; thence south-eastwards along the said street to its junction with Livadhion Street; thence westwards along the last mentioned street to its junction with Hercules Street; thence southwards along the last mentioned street to its junction with Herodotus Street; thence westwards along the last mentioned street to its junction with Acropolis Street; thence southwards along the last mentioned street to its junction with Hilarion Street; thence south-westwards along the last mentioned street to its junction with Ayios Neophytos Street; thence south-eastwards along the last mentioned street to its junction with another road, which junction is at the south-eastern corner of plot No. 50 of the Government Survey Plan No. XXXIII.21.4.III; thence eastwards along the last mentioned road to its junction with another road, which junction is at the most eastern point of plot No. 38 of the said plan; thence south-westwards along the last mentioned road, crossing the Dherinia-Varosha main road, to its junction with another road, which junction is at the south-western corner of plot No. 31 of the Government Survey Plan No. XXXIII.28.3.II; thence northwards along the last mentioned road to the point of commencement.

All the area within the said boundary is shown coloured red and hatched blue on the Government Survey Plan Serial No. 1418.

*Kato Varosha Quarter.*

The boundary commences at the most western point of plot No. 1 of the Government Survey Plan No. XXXIII.19.W.2, locality "Kamini tou Kiayia", which point is on the main road from Larnaca Town to Famagusta Town, and proceeds north-eastwards along the said road to its junction with Demetra Street; thence south-eastwards and southwards along the said street and Demophon Street to the junction of the last mentioned street with Ayia Paraskevi Street; thence westwards along the last mentioned street to its junction with Alcamenes Street; thence south-eastwards along the last mentioned street to its junction with the main road from the village of Dherinia to Varosha Town; thence southwards along the said main road to its junction with another road, which junction is at the south-eastern corner of plot No. 42 of the Government Survey Plan No. XXXIII.28.E.1; thence westwards along another road, leading to the village of Phrenaros, to the junction of roads at the south-western corner of plot No. 23 of the Government Survey Plan No. XXXIII.28.W.2, locality "Dhyo Loutsia"; thence northwards along another road, leading to Varosha Town, to the most eastern point of plot No. 276 of the Government Survey Plan No. XXXIII.28.W; thence north-westwards along the boundaries of and including plots Nos. 276, 180, 232 and 238 of the said plan to the most western point of the last mentioned plot, which point is on the stream "Pharankas"; thence south-westwards up the said stream to the most southern point of plot No. 195 of the said plan, locality "Kremni"; thence north-westwards along the boundaries of and including plots Nos. 195 and 196 of the said plan, plots Nos. 243 and 127 of the Government Survey Plan No. XXXIII.27.E, locality "Ayios Yeoryios tou Pharankou", plots Nos. 212, 207 and 260 of the Government Survey Plan No. XXXIII.19.E, to the most western point of the last mentioned plot, locality "Kamini tou Kiayia", which point is on a road; thence south-westwards along the said road to the point of commencement.

All the area within the said boundary is shown coloured yellow on the Government Survey Plan Serial No. 1418.

*Stavros Quarter.*

The boundary commences at the junction of Ayios Neophytos Street with Hilarion Street and proceeds north-eastwards along the last mentioned street to its junction with Acropolis Street; thence northwards along the last mentioned street to its junction with Herodotus Street; thence eastwards along the last mentioned street to its junction with Hercules Street; thence northwards along the last mentioned street to its junction with Livadhion Street; thence eastwards along the last mentioned street to the north-western corner of plot No. 20 of the Government Survey Plan No. XXXIII.13.4.IV; thence eastwards along the boundaries of and including plots Nos. 20 and 233 of the said plan to the seashore; thence southwards along the seashore to the most northern point of plot No. 172 of the Government Survey Plan No. XXXIII.21.5.II; thence westwards along the boundaries of but excluding plots Nos. 172 and 1 of the said plan to the north-western corner of the last mentioned plot, which corner is on a road; thence southwards along the said road to its junction with another road, which junction is at the south-eastern corner of plot No. 148 of the said plan; thence westwards along the last mentioned road to its junction with another road, which junction is at the north-western corner of plot No. 182 of the said plan; thence northwards along the last mentioned road to its junction with another road, which junction is at the north-eastern corner of plot No. 38 of the Government Survey Plan No. XXXIII.21.5.I; thence south-westwards along the last mentioned road to its junction

with another road, which junction is at the south-western corner of plot No. 145 of the Government Survey Plan No. XXXIII.21.4.IV; thence north-westwards along the last mentioned road to its junction with another road, which junction is at the north-eastern corner of plot No. 38 of the Government Survey Plan No. XXXIII.21.4.III; thence westwards along the last mentioned road to its junction with another road, which junction is at the most southern point of plot No. 50 of the said plan; thence northwards along the last mentioned road to the point of commencement.

All the area within the said boundary is shown coloured green on the Government Survey Plan Serial No. 1418.

*Ayios Memnon Quarter.*

The boundary commences at the most western point of plot No. 1 of the Government Survey Plan No. XXXIII.28.3.II, which point is on a road, and proceeds north-eastwards along the said road, crossing the Dherinia-Varosha road, to its junction with another road, which junction is at the south-western corner of plot No. 145 of the Government Survey Plan No. XXXIII.21.4.IV; thence eastwards along the last mentioned road to its junction with another road, which junction is at the north-eastern corner of plot No. 38 of the Government Survey Plan No. XXXIII.21.5.I; thence southwards along the last mentioned road to its junction with another road, which junction is at the north-western corner of plot No. 182 of the Government Survey Plan No. XXXIII.21.5.II; thence eastwards along the last mentioned road to its junction with another road, which junction is at the south-eastern corner of plot No. 148 of the said plan; thence northwards along the last mentioned road to the north-western corner of plot No. 1 of the said plan; thence eastwards along the boundaries of and including plots Nos. 1 and 172 of the said plan to the seashore; thence south-eastwards along the seashore to the mouth of the stream which is the southern boundary of plot No. 192 of the Government Survey Plan No. XXXIII.30.4.III, locality "Linnara"; thence south-westwards up the said stream to the most eastern point of plot No. 197 of the said plan, locality "Dhromos tou Xenti"; thence south-westwards and north-westwards along a road to the junction of roads at the most eastern corner of plot No. 199 of the Government Survey Plan No. XXXIII.29.6.IV, locality "Exintara"; thence south-westwards along a road to the most southern point of plot No. 209 of the Government Survey Plan No. XXXIII.37.3.I, locality "Beylitika", which point is on the aqueduct; thence north-westwards along the aqueduct to the road at the southern boundary of plot No. 60 of the Government Survey Plan No. XXXIII.29.2.III, on which stands Ayios Memnon Church; thence south-westwards along the said road to its junction with the main road from the village of Dherinia to Varosha Town, which junction is at the most southern point of plot No. 41 of the Government Survey Plan No. XXXIII.29.4.I, locality "Tekkelitika"; thence north-westwards along the said main road to its junction with another road, which junction is at the most southern point of plot No. 66 of the Government Survey Plan No. XXXIII.29.1.III; thence north-westwards along the last mentioned road to the point of commencement.

All the area within the said boundary is shown coloured brown and hatched black on the Government Survey Plan Serial No. 1418.
