ORDER MADE BY A COMPETENT AUTHORITY UNDER DEFENCE
REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as Competent Authority for the purpose of Defence Regulation 61 as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946, I hereby order as follows :—

1. This Order may be cited as the Supplies and Services (Raisins Control) Order, 1949.

2. In this Order—

“appointed day” means the 14th day of September, 1949 ;

“authorized purchaser” means a person or body of persons duly authorized by the Vine Products Controller to purchase raisins ;

“dealer by retail” means any person selling raisins to a purchaser buying in such quantities as may be reasonably required for use or consumption in the purchaser’s household for a reasonable time and not for the purpose of resale ;

“permit” means a written permit issued under the provisions of this Order either by the Vine Products Controller or by any person authorized by him in that behalf ;

“producer” means any person who, after the appointed day, produces any raisins either by his own labour or through his agents or servants ;

“purchase” includes an agreement, offer or attempt to purchase, or the making of any arrangements to purchase either directly or indirectly ;

“purchase by retail” means any purchase in such quantities as may be reasonably required for use or consumption in the purchaser’s household for a reasonable time and not for the purpose of resale ;

“raisins” means boiled, scalded or sun dried raisins produced in Cyprus but does not include sultanas ;

“sell” includes an agreement, offer or attempt to sell or the making of any arrangements to sell either directly or indirectly ;

“Vine Products Controller” means an officer appointed by the Governor as Vine Products Controller.

3. Within seven days from the date of the publication of this Order in the *Gazette*, and thereafter from the date of a notice in the *Gazette* to this effect by the Vine Products Controller, every person who has in his possession or under his control any quantity of raisins in excess of twenty okes shall complete and deliver to the Vine Products Controller a return in the form set out in the Schedule hereto in respect of the raisins in his possession or under his control.

4. Save under a permit, no producer shall, after the appointed day, sell any raisins except to an authorized purchaser.

5. Save under a permit, no person shall, after the appointed day, transport, move or permit or suffer to be transported or moved any raisins from his town or village except for the purpose of their delivery to an authorized purchaser.

6. Save under a permit, no person, other than an authorized purchaser, shall, after the appointed day, purchase any raisins: Provided that any person may purchase by retail from any dealer by retail any raisins reasonably required for use or consumption in the purchaser's household for a reasonable time.

7. No person who is not a producer or an authorized purchaser or the holder of a permit shall, after the appointed day, have in his possession or under his control any quantity of raisins, in excess of twenty okes.

8. The Vine Products Controller or any other person authorized by him in that behalf may—

- (a) attach such terms or conditions as he may think fit to any permit, and the holder of any such permit shall comply with all such terms and conditions;
- (b) revoke any such permit.

9. Every person shall permit such person as the Vine Products Controller or the Commissioner of the District may authorize in writing in that behalf to enter upon and inspect his premises for the purpose of ascertaining whether the provisions of this Order have been or are being complied with or for the purpose of checking the correctness or accuracy of any return made under this Order.

10. Any person who—

- (a) acts in contravention of or fails to comply with any of the provisions of this Order;
- (b) fails to comply with any term or condition in any permit;
- (c) makes, under any of the provisions of this Order, any return which is false in any material particular;
- (d) knowingly misleads or otherwise interferes with or impedes any person exercising any powers or performing any duties under the provisions of this Order,

is liable to the penalties prescribed in the Defence Regulations as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946.

DISSOLUTION OF THE IRRIGATION DIVISION OF KATO PYRGOS,
 PANO PYRGOS AND AYIOS IOANNIS (SELEMANI).

Whereas at a meeting of the proprietors of the Irrigation Division of Kato Pyrgos, Pano Pyrgos and Ayios Ioannis (Selemani) held at the village of Kato Pyrgos on the 31st July, 1949, it was decided by the requisite majority of the voters present thereat that the said Irrigation Division should be dissolved:

Now, therefore, it is hereby notified that the Irrigation Division of Kato Pyrgos, Pano Pyrgos and Ayios Ioannis (Selemani) has been dissolved accordingly as from the 31st July, 1949, subject to the reservations and exceptions contained in section 22A of the Irrigation Divisions (Villages) Laws, 1938 to 1949, and the Irrigation Division of Kato Pyrgos, Pano Pyrgos and Ayios Ioannis (Selemani) Rules, 1940.
