THE TREE PLANTING (VILLAGE AREAS) LAW, 1948.

ORDER MADE UNDER SECTION 12.

Whereas at a meeting duly convened and held at the village of Omodhos in the District of Limassol on the 17th July, 1949, under the provisions of the Tree Planting (Village Areas) Law, 1948, it was determined by the requisite majority of the owners present thereat that a certain area should be reserved as the Tree Planting Area of the said village of Omodhos ;

And whereas the Mukhtar of the said village of Omodhos has forwarded to me a report signed and sealed by him containing a description of the area in question with boundaries and particulars and stating that such area fulfils the conditions prescribed in section 10 (4) of the said Law :

Now, therefore, I, the Commissioner of the District of Limassol, having approved of the said report, do by this order declare that the area described in the Schedule hereto shall be reserved as the Tree Planting Area of the said village of Omodhos.

SCHEDULE.

The area lying within the following boundary, that is to say :—

The boundary commences at the most northern point of plot No. 7 of the Government Survey Plan No. XLVII.26, locality " Kalavasidhia ", which point is at the junction of the carriage road, between the village of Omodhos and the village of Mandria, with Karydhaki River and proceeds southwards along the right bank of the said river to the most northern point of plot No. 351 of the said plan, locality " Era ", which point is at the junction of the said river with a stream ; thence eastwards along the said stream to the north-eastern point of plot No. 339 of the said plan, locality " Kidhiadhes " ; thence south-eastwards and north-eastwards along the boundaries of and including plots Nos. 339, 338, 337, 333, 330, 329, 327, 324 and 323 of the said plan to the north-eastern point of the last mentioned plot, locality " Polemi ", which point is on the boundary between the villages of Omodhos and Mandria ; thence southwards along the said village boundary to the most eastern point of plot No. 309 of the said plan, locality " Pernia ", which point is on a road leading from the village of Omodhos to the village of Kilani ; thence south-westwards along the said road to the most southern point of plot No. 224 of the said plan, locality " Vrysi tou Poulenkeri ", which point is at a road junction ; thence south-westwards along the boundaries of and including plots Nos. 172, 173, 138, 137, 136, 135, 134 and 133 of the said plan, locality " Kambos tou Papa Theodorou ", plots Nos. 24, 22, 93, 114, 115, 121, 122, 132, 131, 133, 135, 136, 141, 140, 139, 176, 177, 178, 181 and 182 of the Government Survey Plan No. XLVII.34, locality " Plevres tou Mesariti ", plots Nos. 798, 797 and 796 of the Government Survey Plan No. XLVII.33, locality " Mosphilia " to the most southern point of the last mentioned plot, which point is on the left bank of the said river ; thence southwards across the said river to its right bank ; thence along the said bank of the said river to its junction with a stream at the most southern point of plot No. 909 of the said plan, locality " Laonin tou Spanou " ; thence westwards along the said stream to the most southern point of plot No. 333 of the Government Survey Plan No. XLVII.41, which point is on the boundary between the villages of

Omodhos and Potamiou ; thence westwards along the said boundary to its junction with the boundary between the villages of Omodhos and Vasa ; thence north-westwards along the said boundary to the south-western point of plot No. 393, Government Survey Plan No. XLVII.33, locality " Ambellia tou Louka ", which point is on the carriage road between the village of Omodhos and the village of Mallia ; thence north-eastwards along the said carriage road to the most northern point of plot No. 529 of the said plan, locality " Ayios Spyridon ", which point is on the junction of the said carriage road with a stream ; thence eastwards along the said stream to the most southern point of plot No. 706 of the said plan, which point is on the track between the village of Omodhos and the village of Potamiou ; thence northwards along the said track to the north-western point of plot No. 715 of the said plan, locality " Vryssia " ; thence eastwards along the boundaries of and including plots Nos. 715, 734, 724, 718, 719, 720, 722, 647, 646, 645 and 644 to the north-eastern point of the last mentioned plot of the said plan, locality " Skasmata ", which point is on the right bank of a river ; thence eastwards across the said river to its left bank ; thence northwards along the said bank of the said river to the north-eastern point of plot No. 559 of the Government Survey Plan No. XLVII.25, locality " Gouppo " ; thence north-westwards (across the said river) along the boundaries of and including plots Nos. 556, 555, 477, 478, 479, 480, 464, 462, 461, 460, 457, 433, 434, 428 and 429 of the said plan, locality " Stallia ", to the most northern point of the last mentioned plot, which point is on the carriage road between the village of Omodhos and the village of Mandria ; thence north-eastwards along the said carriage road to the point of commencement. All which said boundary is shown edged in red on the Government Survey Plan, Serial No. 1454, and surrounds an area of 1,905 donums or thereabouts.
