No. 119. THE LAND ACQUISITION LAWS, 1899 TO 1947.

NOTICE UNDER SECTION 5.

With reference to the Notification published under No. 341 in Supplement No. 3 to the *Gazette* No. 3393 of 16.9.48 notice is hereby given that the following lands are required by the Governor for the undertaking of public utility mentioned therein:—

“ Nicosia Bye-pass.—Plan No. 4 : Areas falling in Orta Keuy and Ayios Dhometios villages ”.

2. Any person claiming to have any right or interest in the said lands is required within six weeks from the date of this notice to send to me a statement of his right and interest and of the evidence thereof, and of any claim made by him in respect of such right or interest.

3. The Governor is willing to treat for the acquisition of the said lands.

4. Plans showing the lands described above are available for inspection at my office in Nicosia.

No. 120. THE BURIALS LAWS, 1896 AND 1937.

ORDER UNDER SECTION 1.

THE SHEEP AND GOATS (SHEPHERDS' LICENSING AND CONTROL) LAW, 1948.

NOTICE UNDER SECTION 12.

In exercise of the powers vested in me by section 12 of the Sheep and Goats (Shepherds' Licensing and Control) Law, 1948, I hereby direct that during the period between the 31st March, 1950, and 30th April, 1950, flocks within the area of Eylenja, Yeri and Laxia, Nicosia District, shall, between the hours of sunset and sunrise, be kept inside an enclosure and not taken outside an enclosure :

Provided that nothing in this notice contained shall prevent the driving of any flock, under the proper charge of a licensed shepherd, from one village area to another, along any public road, at any hour.
