No. 155. DECLARATION BY THE GOVERNOR-IN-COUNCIL.

No. 156. THE BURIALS LAWS, 1896 AND 1937.

ORDER MADE UNDER SECTION 14.

Whereas in pursuance of an order published in Supplement No. 3 to the *Gazette* of the 27th February, 1947, a fit and proper site has been registered in the books of the Land Registry Office for use as a burial ground by the Moslem community of the village of Episcopi, in the District of Limassol:

Now, therefore, in exercise of the powers vested in the Governor by section 14 of the Burials Laws, 1896 and 1937, and duly delegated to me under Notification No. 172, published in Supplement No. 3 to the *Gazette* of the 19th June, 1947, I do hereby order that no burial shall take place in the burial ground in lieu whereof the new burial ground above referred to has been provided.
