THE TREE PLANTING (VILLAGE AREAS) LAW, 1948.

ORDER MADE UNDER SECTION 12.

Whereas at a meeting duly convened and held at the village of Skarinou in the District of Larnaca on the 28th of May, 1950, under the provisions of the Tree Planting (Village Areas) Law, 1948, it was determined by the requisite majority of the owners present thereat that certain areas should be reserved as a Tree Planting Area of the said village of Skarinou ;

And whereas the Mukhtar of the said village of Skarinou has forwarded to me a report signed and sealed by him containing a description of the areas in question with boundaries and particulars and stating that such areas fulfil the conditions prescribed in section 10 (4) of the said Law :

Now, therefore, I, the Commissioner of the District of Larnaca, having approved the said report, do by this Order declare that the areas described in the Schedule hereto shall be reserved as the Tree Planting Area of the said village of Skarinou.

SCHEDULE.

Area " A ".

The area lying within the following boundaries that is to say :—

The boundary commences at the north-western corner of plot No. 258 of the Government Survey Plan No. XLIX.38, locality " Havva ", which corner is on the village boundary between the villages of Skarinou and Pano Lefkara and proceeds eastwards along the said boundary to its junction with the boundary between the villages of Kophinou and Skarinou, which junction is at the most northern point of plot No. 262 of the said plan, locality " Skouros " ; thence south-eastwards and southwards along the said boundary to the most southern point of plot No. 58 of the Government Survey Plan No. XLIX.47, locality " Lakxies ", which point is on the left bank of " Vreis River " ; thence north-westwards along the left bank of the said river to the point of commencement.

Area " B ".

The area lying within the following boundaries that is to say :—

The boundary commences at the north-western corner of plot No. 16 of the Government Survey Plan No. XLIX.55, locality " Lakxies ", which corner is on the village boundary between the villages of Skarinou and Kophinou and proceeds south-eastwards along the said boundary to its junction with the boundary between the villages of Skarinou and Ayios Theodoros, which junction is at the south-eastern corner of plot No. 18 of the said plan, locality " Vounos " ; thence south-westwards along the said boundary to the most southern point of plot No. 47 of the said plan, which point is on the left bank of " Vreis River " ; thence north-westwards and northwards along the left bank of the said river to the point of commencement. All which said boundaries are shown edged red on the Government Survey Plan Serial No. 1480 and surround an area of 1,376 donums or thereabouts.
