THE STREETS AND BUILDINGS REGULATION LAW, 1946.

REGULATIONS MADE UNDER SECTION 19.

A. B. WRIGHT,  
*Governor.*

In exercise of the powers vested in me by section 19 of the Streets and Buildings Regulation Law, 1946, I, the Governor, with the advice of the Executive Council, do hereby make the following regulations:—

1. These regulations may be cited as the Streets and Buildings (Amendment No. 2) Regulations, 1949, and shall be read as one with the Streets and Buildings Regulations, 1946 and 1949 (hereinafter referred to as "the principal Regulations."), and the principal Regulations and these regulations may together be cited as the Streets and Buildings Regulations, 1946 to (No. 2) 1949.

2. Paragraph 2 of regulation 62 of the principal Regulations is hereby amended by the deletion therefrom of the words "Council of the Municipal Corporation of Limassol" (line 2 as set out in the Streets and Buildings (Amendment) Regulations, 1949) and the substitution therefor of the words "Councils of the Municipal Corporations of Nicosia and Limassol".

3. The Schedule to the principal Regulations is hereby amended by the deletion therefrom of Part II and the substitution therefor of the following Part:—

"PART II.

FEEs FOR PERMITS IN RESPECT OF DOMESTIC AND PUBLIC BUILDINGS  
IN NICOSIA AND LIMASSOL (IN LIEU OF THE FEES SET OUT IN  
PARAGRAPH 2 (a) OF PART I).

Description	Nicosia	Limassol
(i) Where the cubical content of the building does not exceed 15,000 cubic feet, for every 1,000 cubic feet, or fraction thereof, of the cubical content of the building .. .. .	10s.	8s.
(ii) Where the cubical content of the building exceeds 15,000 cubic feet but not 30,000 cubic feet, for every 1,000 cubic feet, or fraction thereof, of the cubical content of the building .. .. .	15s.	15s.
(iii) Where the cubical content of the building exceeds 30,000 cubic feet, for every 1,000 cubic feet, or fraction thereof, of the cubical content of the building .. .. .	20s.	20s."
