

- (b) the Municipal Corporation shall, in each year and until final repayment of the sum borrowed, insert in the annual estimates as a charge on its revenues the annual sum payable as aforesaid in the year to which such estimates relate ;
- (c) the sum borrowed shall be utilized by the Municipal Corporation for asphaltting the main streets within the municipal limits of Athienou.

2. For the purpose of securing the repayment of the sum under the loan, the Municipal Corporation is hereby authorized, subject to any prior mortgage thereon, to mortgage to the Lender all the rates, fees and duties now payable or hereafter to become payable to the Municipal Corporation.

No. 114. THE POST OFFICE LAWS, 1881 TO 1933.

ORDER IN COUNCIL No. 2467
MADE UNDER SECTION 6.

In exercise of the powers vested in me by section 6 of the Post Office Laws, 1881 to 1933, I, the Governor, with the advice of the Executive Council, do hereby order as follows:—

1. This Order may be cited as the Post Office (Rates of Postage and Postal Charges) (Amendment) Order, 1951, and shall be read as one with the Post Office (Rates of Postage and Postal Charges) Order, 1950 (hereinafter referred to as "the principal Order") and the principal Order and this Order may together be cited as the Post Office (Rates of Postage and Postal Charges) Orders, 1950 and 1951.

2. Part I of the Schedule to the principal Order is hereby amended as follows:—

- (i) by the deletion from paragraph 1 thereof under the heading "FOR ABROAD" of the heading "TO THE BRITISH EMPIRE GENERALLY, TERRITORIES UNDER BRITISH MANDATE AND BRITISH POST OFFICE IN MOROCCO" and the substitution therefor of the heading "TO ALL PARTS OF THE BRITISH COMMONWEALTH, TO ALL TERRITORIES UNDER BRITISH TRUSTEESHIP AND TO BRITISH POST OFFICE AT TANGIER";
- (ii) by the deletion from paragraph 1 thereof of entry (g) relating to "Small Packets" and the substitution thereof of the following entry:—

(g) <i>Small Packets</i> :	<i>Piastres</i>
Not exceeding 10 oz.	6
For every additional 2 oz. or fraction thereof	1 $\frac{1}{4}$

- (iii) by the deletion from paragraph 2 thereof under the heading "TO FOREIGN COUNTRIES" of the entries relating to (a) "Letters", (b) "Postcards", (d) "Commercial Papers", (g) "Small Packets" and (h) "Insured Boxes" and the substitution therefor of the following entries respectively:—
