Price when sold by Government to bakers and to authorized distributors for making bread ..	8 5/40 piastres per oke.

Price when sold by Government to macaroni manufacturers, confectioners, and other retailers for purposes other than for making bread ..	12 piastres per oke.

the term ‘bread’ does not include franzola or what are commonly known as *koullouria* and *paximadia*.”
