THE FOREST LAW.

CAP. 93.

ORDER IN COUNCIL No. 2494

MADE UNDER SECTION 3.

In exercise of the powers vested in me by section 3 of the Forest Law, Cap. 93 I, the Acting Governor, with the advice of the Executive Council, do hereby order as follows :—

1. This Order may be cited as the Minor State Forests (Famagusta) (Amendment) Order, 1951, and shall be read as one with the Minor State Forests (Famagusta) Orders, 1943 to 1950 (hereinafter referred to as "the principal Order"), and the principal Order and this Order may together be cited as the Minor State Forests (Famagusta) Orders, 1943 to 1951.

2. The Schedule to the principal Order is hereby amended as follows :—

(a) by the deletion therefrom of the area No. 13 (relating to the village of Milia) and the substitution therefor of the following area :—

" 13. *Milia in the District of Famagusta :*

A portion of the Crown land under plot No. 181/14 of Sheet XXIII, plan 14W.E. at the locality 'Vikla Paymaes' demarcated by boundary marks numbered consecutively from 1 to 33 inclusive, comprising 58 donums 1 evlek and 2,700 sq. ft. approximately and shown on the Government Survey Plan Serial No. 1453 delineated thereon in green."

(b) by the addition thereto immediately after the area No. 30 (relating to the village of Phrenaros) of the following areas :—

" 31. *Gastria in the District of Famagusta :*

A portion of the Crown land under plot 68/2 of Sheet XV, plan 21E.W. at the locality 'Kouroulli' demarcated by boundary marks numbered consecutively from 1 to 55 inclusive, comprising 56 donums approximately and shown on the Survey Plan Serial No. 1441 delineated thereon in green.

32. *Dherinia in the District of Famagusta :*

A portion of the Crown land under plots 343 and 346, Sheets XXXIII, plan 26 and 27 and XXXIII, plan 34 and 35 at the locality 'Kourkounia' demarcated by boundary marks numbered consecutively from 1 to 25 inclusive, comprising 66 donums approximately and shown on the Survey Plan Serial No. 1450 delineated thereon in green.

33. *Ayios Theodoros in the District of Famagusta :*

A portion of the Crown land under plot 424 of Sheet XV, plan 7E. at the locality 'Stephani' demarcated by boundary marks numbered consecutively from 1 to 34 inclusive, comprising 56 donums 1 evlek and 2,400 sq. ft. approximately and shown on the Survey Plan Serial No. 1449 delineated thereon in green.

34. *Aloa in the District of Famagusta :*

A portion of the Crown land under plot 41.1, Sheet XXIII, plan 16E.W. at the locality 'Ayios Pappos' demarcated by boundary marks numbered consecutively from 1-13 inclusive, comprising 86 donums approximately and shown on the Survey Plan Serial No. 1459 delineated thereon in green.

35. *Sandalaris in the District of Famagusta :*

A portion of the Crown land under plot 11/17, Sheet XXIII, plan 23W. at the locality 'Moutti' demarcated by boundary marks numbered consecutively from 1-17 inclusive, comprising 153 donums and 3,300 sq. ft. approximately and shown on the Survey Plan Serial No. 1488 delineated thereon in green.

36. *Arnadhi in the District of Famagusta :*

A portion of the Crown land under plot 384.5, Sheet XXIV, plan 1.W. at the locality 'Laxies tou Kirkiti' demarcated by boundary marks numbered consecutively from 1-13 inclusive, comprising 90 donums 1 evlek and 2,400 sq. ft. approximately and shown on the Survey Plan Serial No. 1461 delineated thereon in green and marked 'A'.

37. *Ayios Yeoryios in the District of Famagusta :*

(a) A portion of the Crown land under plot 16/6, Sheet XXIV, plan 1.W. at the locality 'Laxies tou Kirkiti' demarcated by boundary marks numbered consecutively from 1-13 thence southwards to boundary marks numbered 4 thence westwards through boundary marks Nos. 3 and 2 to boundary mark No. 1 inclusive comprising 120 donums approximately and shown on the Survey Plan Serial No. 1461 delineated thereon in green and marked 'B'.

(b) A portion of the Crown land under plot 5/1, Sheet XXIV, plan 1.W. at the locality 'Laxies tou Kirkiti' demarcated by boundary marks numbered consecutively from 1-15 inclusive, comprising 45 donums 1 evlek and 1,200 sq. ft. approximately and shown on the Government Survey Plan Serial No. 1461, delineated thereon in green and marked 'C'."
