## NOTIFICATION UNDER SECTION 65.

## No. 386. THE TREE PLANTING (VILLAGE AREAS) LAW.

CAP. 175.

## ORDER MADE UNDER SECTION 20.

In exercise of the powers vested in me by section 20 of the Tree Planting (Village Areas) Law, I do hereby order that the Order relating to the Tree Planting Area of the village of Alethriko, published under Notification No. 749 of the *Cyprus Gazette* No. 2530 of 7th August, 1936, the extension whereof for a further period of five years was published in Supplement No. 3 to the *Gazette* of 2nd May, 1946, which expires on the 7th September, 1951, shall be extended for a further period of five years from the date of the expiration thereof.
