No. 5. THE WATER (DOMESTIC PURPOSES) VILLAGE SUPPLIES LAW, 1948.

BYE-LAWS MADE BY THE WATER COMMISSION OF AKAPNOU UNDER SECTION 29.

In exercise of the powers vested in them by section 29 of the Water (Domestic Purposes) Village Supplies Law, 1948, the Water Commission of Akapnou village hereby make the following bye-laws:—

1. These bye-laws may be cited as the Village Domestic Water Supply (Akapnou) Bye-laws, 1950.

2.—(1) Subject to the provisions of paragraphs (2) and (3) of this bye-law, the Village Domestic Water Supply (Elea) Bye-laws, 1950, published in the *Gazette* of 1st November, 1950, shall—

(a) be deemed to be bye-laws made by the Water Commission of Akapnou and to be incorporated herein, and

b) apply to the village of Akapnou.

(2) The bye-laws set out in Part I of the Schedule hereto shall be substituted for the corresponding bye-laws of the Village Domestic Water Supply (Elea) Bye-laws, 1950.

(3) Those bye-laws of the Village Domestic Water Supply (Elea) Bye-laws, 1950, mentioned in Part II of the Schedule hereto, shall not apply to the village of Akapnou.

SCHEDULE.

PART I.

Bye-laws to be substituted.

Bye-law 2.—In these bye-laws, unless the context otherwise requires—

“Commissioner” means the Commissioner of the District of Limassol and includes an Assistant Commissioner of that District;

“Law” means the Water (Domestic Purposes) Village Supplies Law, 1948, and any law amending or substituted for the same;

“Village” means the village of Akapnou;

“Water” means the water of the water supply;

“Water Commission” means the Water Commission of Akapnou village;

“Water Supply” means the supply of water for the domestic purposes used or constructed under the Law in the village of Akapnou and includes all wells, bores, reservoirs, dams, weirs, tanks, cisterns, tunnels, filterbeds, conduits, aqueducts, mains, pipes, fountains,
