THE MUNICIPAL CORPORATIONS LAW.
CAP. 252 AND LAW 11 OF 1950.

NOTIFICATION UNDER SECTION 129.

Whereas the properties described in the Schedule hereto are required by the mayor, deputy mayor, councillors and townsmen of Nicosia (hereinafter referred to as "the municipal corporation") for the purpose of widening Ledra and Hermes Streets within the municipal limits of Nicosia; And whereas the formalities prescribed by sections 127 and 128 of the Municipal Corporations Law have been complied with; And whereas I, the Acting Governor, have approved the plan submitted in that behalf, and consider it expedient, having regard to all the circumstances, that the municipal corporation should be permitted to acquire the said properties for the above public purpose: Now, therefore, in exercise of the powers vested in me by section 129 of the Municipal Corporations Law, I, the Acting Governor, do hereby sanction the acquisition of the properties described in the Schedule hereto by the municipal corporation.
