

NOTICE UNDER SECTION 95 (1).

Acting Governor.

In exercise of the powers vested in me by section 95 (1) of the Elementary Education Law and otherwise, I, the Acting Governor, do hereby direct that the additional tax mentioned in section 86 of the said Law payable by the Moslem taxpayers of the villages mentioned in the Schedule hereto shall be increased in the year of 1952 by such rate per thousand as is shown opposite the name of each village to provide the amount required for the payment of loans or annual maintenance of the Moslem Schools of the said villages, respectively.

CAP. 252 AND LAW 11 OF 1950.

NOTICE UNDER SECTION 112.

In exercise of the powers vested in me by section 112 of the Municipal Corporations Law, I, the Acting Governor, do by this notice direct that for the year ending 31st December, 1952, there shall be raised, levied and collected immovable property tax on the immovable property within the limits of the Municipal Corporations set out in this Schedule hereto owned by Moslems at the percentage of the capital value of such property set out opposite the name of each of the said Municipal Corporations.
