

**No. 8.****THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS)  
(CYPRUS) ORDER, 1946.****APPOINTMENT OF COMPETENT AUTHORITY UNDER DEFENCE  
REGULATION 3.**

In exercise of the powers vested in me by Defence Regulation 3 as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946, I, the Governor, do hereby appoint the Colonial Secretary to be a Competent Authority for the purposes of Defence Regulations 61, 61A, 63 and 83 as set out in the aforesaid Schedule.

2. This appointment is in addition to and not in derogation of any other appointment made for the purposes of the said Defence Regulation or any of them in respect of any officer or person other than the Controller of Supplies, but without prejudice to anything done by any such officer or person.

(CYPRUS) ORDER, 1946.****DELEGATION OF POWERS UNDER PARAGRAPH (2) OF DEFENCE  
REGULATION 55.**

In exercise of the powers vested in me by paragraph (2) of Defence Regulation 55 as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946, I, the Governor, do hereby depute the Colonial Secretary to exercise and perform in my behalf all the powers which I am empowered to exercise and perform under the provisions of paragraph (1) of the aforesaid Defence Regulation 55.

2. This delegation shall be deemed to have been made on the 1st day of January, 1951, and the delegation made by the Acting Governor on the 16th day of February, 1949, and published under Notification No. 81 in Supplement No. 3 to the *Gazette* of the 24th February, 1949, shall be deemed to have been revoked as from the 1st day of January, 1951.

**No. 10.****THE TRADING WITH THE ENEMY LAWS, 1939 TO 1945.****APPOINTMENT MADE BY THE GOVERNOR UNDER SECTION 9 (1).**
