NOTICE UNDER SECTION 12.

In exercise of the powers vested in me by section 12 of the Sheep and Goats (Shepherds' Licensing and Control) Law, I hereby direct that during the period between the 1st April, 1952, and the 30th September, 1952, flocks within the area of the village of Arakapas, in the District of Limassol, shall, between the hours of sunset and sunrise, be kept inside an enclosure and not taken outside an enclosure:

Provided that nothing in this notice contained shall prevent the driving of any flock, under the proper charge of a licensed shepherd, from one village to another, along any public road, at any hour.

THE VILLAGE AUTHORITIES LAW.
CAP. 256 AND LAW 17 OF 1951.

SPECIAL AUTHORIZATION UNDER SECTION 14 (1).

By virtue of the powers vested in the Governor by section 14 (1) of the Village Authorities Law, and duly delegated to me, I hereby authorize the Mukhtars the names whereof are mentioned in the Schedule hereto to issue, on the application in writing of a police officer of any rank not lower than that of Sergeant, Class II, or of any police officer in charge of a Police Station, warrants for the purposes of the said section of the said Law.

2. All previous authorizations to Mukhtars in the Paphos District under section 14 (1) of the Village Authorities Law are hereby revoked without prejudice to anything done thereunder.
