

- (b) by permit under his hand, permit any licensed premises to which clauses 3 and 4 of this Order apply to remain open up to midnight, on any night or during such period as may be specified in the permit, upon payment of two shillings for every hour of extension ;
- (c) by special permit under his hand, extend the time during which any licensed premises to which clauses 3 and 4 of this Order apply may remain open after midnight on any special night for any special occasion, upon payment of two shillings for every hour of extension.

NOTIFICATION UNDER SECTION 129.

Whereas the property described in the Schedule hereto is required by the Mayor, Deputy Mayor, Councillors and Townsmen of Lapithos (hereinafter referred to as "the Municipal Corporation") for the public purpose of supplying the community of Lapithos with drinking water ;
