2. For the purpose of securing the repayment of the sum under the loan, the Board shall, subject to any prior mortgage thereon, mortgage to the Lenders all the rates, fees, rents, tolls or charges now payable or hereafter to become payable to the Board.

No. 411. THE WATER (DOMESTIC PURPOSES) VILLAGE SUPPLIES LAW. CAP. 311 AND LAWS 28 OF 1951 AND 12 OF 1952.

Bye-laws made by the Water Commission of Vouno Village (Kyrenia District) under Section 29.

In exercise of the powers vested in them by section 29 of the Water (Domestic Purposes) Village Supplies Law, the Water Commission of Vouno village, in the District of Kyrenia, hereby make the following bye-laws:—

- 1. These bye-laws may be cited as the Village Domestic Water Supply (Vouno) Bye-laws, 1952.
- 2.—(1) Subject to the provisions of paragraphs (2) and (3) of this bye-law, the Village Domestic Water Supply (Elea) Bye-laws, 1950, published in the *Gazette* of 1st November, 1950, shall—
  - (a) be deemed to be bye-laws made by the Water Commission of Vouno and to be incorporated herein, and

(b) apply to the village of Vouno.

(2) The bye-laws set out in Part I of the Schedule hereto shall be substituted for the presponding bye-laws of the Village Domestic Water Supply (Elea) Bye-laws, 1950.

(3) Those bye-laws of the Village Domestic Water Supply (Elea) Bye laws, 1950, mentioned in Part II of the Schedule hereto, shall not apply to the village of Vouno.
