With reference to the Notification published under No. 45 in Supplement No. 3 to the *Gazette* of 7th February, 1951, notice is hereby given that the following easement is required for the undertaking of public utility mentioned therein, that is to say, the establishment of a Military Cantonment in the villages of Pyla, Xylotymbou and Ormidhia in the District of Larnaca :—
