THE STREETS AND BUILDINGS REGULATION LAW.

APPOINTMENT OF APPROPRIATE AUTHORITY IN IMPROVEMENT AREAS UNDER  
SECTION 3 (2) (b).

In exercise of the powers vested in me by the first proviso to paragraph (b) of sub-section (2) of section 3 of the Streets and Buildings Regulation Law, I, the Governor, do hereby appoint as appropriate authority—

- (a) for each of the improvement areas set out in the First Schedule hereto a board consisting of the members of the Improvement Board established in each such area, respectively, and functioning for the time being, under the Villages (Administration and Improvement) Law, 1950 ;
- (b) for the improvement area set out in the Second Schedule hereto a board consisting of the persons designated and named in the said Schedule.

In exercise of the powers vested in me by section 35 (*d*) of the Antiquities Law, I, the Governor, with the advice of the Executive Council, do hereby make the following regulations :—

These regulations may be cited as the Antiquities (Admission Fees to Museums and Ancient Monuments) (Amendment) Regulations, 1953, and shall be read as one with the Antiquities (Admission Fees to Museums and Ancient Monuments) Regulations, 1950 and 1952 (hereinafter referred to as "the principal Regulations"), and the principal Regulations and these regulations may together be cited as the Antiquities (Admission Fees to Museums and Ancient Monuments) Regulations, 1950 to 1953.

2. The Schedule to the principal Regulations is hereby amended by the insertion therein, in its appropriate columns under the heading "Nicosia District", of the particulars set out in the columns of the Appendix hereto respectively.
