No. 144. THE MUNICIPAL CORPORATIONS LAW.
CAP. 252 AND LAWS 11 OF 1950 AND 31 OF 1951.

BYE-LAWS MADE BY THE COUNCIL OF THE MUNICIPAL CORPORATION OF NICOSIA.

Cap. 252.
11 of 1950.
31 of 1951.

In exercise of the powers vested in them by the Municipal Corporations Law, and otherwise, the Council of the Municipal Corporation of Nicosia hereby make the following bye-laws:—

1. These bye-laws may be cited as the Municipal Corporation (Nicosia) Pensions and Gratuities (Amendment) Bye-laws, 1953, and shall be read as one with the Municipal Corporation (Nicosia) Pensions and Gratuities Bye-laws, 1939 (hereinafter referred to as "the principal Bye-laws") and the principal Bye-laws and these bye-laws may together be cited as the Municipal Corporation (Nicosia) Pensions and Gratuities Bye-laws, 1939 to 1953.

2. Bye-law 13 of the principal Bye-laws is hereby amended by the deletion of sub-section (2) thereof and the substitution therefor of the following sub-section:—

"(2) The option referred to in sub-section (1) shall be exercisable, and if it has been exercised on or before the date of the publication of this bye-law may be revoked, not later than the day immediately preceding the date of the officer's retirement from a pensionable office."

3. The principal bye-laws are hereby amended by the addition immediately after bye-law 16 of the following bye-law:—

"16A. Where an officer, on retiring from the service of the Corporation on medical evidence under paragraph (d) of bye-law 16 has more than ten years' but less than twenty years' pensionable service, the same pension, if any, may be granted to him as might have been granted to him if his pensionable service had been twenty years."
