No. 246. THE IRRIGATION DIVISIONS (VILLAGES) LAW.

CAP. 111.

In pursuance of the provisions of section 19 of the Irrigation Divisions (Villages) Law, Cap. 111, the following rules made by the Committee of the Irrigation Division of Agridhia ("Pano and Kato Leftina"), in the District of Limassol, are published in the *Gazette*.

IRRIGATION DIVISION OF AGRIDHIA ("PANO AND KATO LEFTINA").

Rules.

1. These rules may be cited as the Irrigation Division of Agridhia ("Pano and Kato Leftina") Rules, 1953.

2. In these rules, unless the context otherwise requires—

"Commissioner" means the Commissioner of the District of Limassol.

"Committee" means the Committee of the Irrigation Division.

"Irrigation Division" means the Irrigation Division of Agridhia ("Pano and Kato Leftina").

"Law" means the Irrigation Divisions (Villages) Law, Cap. 111.

"List" means the list of the names and residence of the proprietors and of the lands and extent thereof which are to be benefited or are capable of being benefited by the works prepared under the provisions of section 15 of the Law as finally settled under the provisions of section 16 of the Law.

"Works" means the irrigation works of the Irrigation Division,
