Whereas by an Order in Council No. 2567 dated the 18th day of October, 1952, published under Notification No. 458 in Supplement No. 3 to the *Gazette* of the 22nd October, 1952 (hereinafter referred to as "the principal Order"), authority was given to the Municipal Commission of Limassol to contract a loan;

And whereas it is found desirable to amend the principal Order;

Now, therefore, in exercise of the powers vested in me by section 124 (a) (i) of the Municipal Corporations Law, and of every other power thereunto enabling, I, the Governor, with the advice of the Executive Council, do hereby order as follows:—

1. The Schedule to the principal Order is hereby amended—

(a) by the addition at the end of item (2) thereof of the words "and from a point opposite the junction of Crete Street and Christodoulos Hadji Pavlos Street up to and including the premises known as 'Akteon Café'";

(b) by the deletion of item (4) thereof;

(c) by the substitution of the following item for item (5) thereof:—  
“(5) Creation of a Square and the erection of an Assembly Room for the Turkish community.”

2. This Order shall be read as one with the principal Order and it shall be deemed to have been made with effect from the 18th day of October, 1952.

In exercise of the powers vested in me by section 124 (a) (i) of the Municipal Corporations Law, I, the Governor, with the advice of the Executive Council, do hereby order as follows:—

1. The Chairman, Deputy Chairman, Members and Townsmen of the Municipal Commission of Limassol (hereinafter referred to as "the Municipal Commission") shall be at liberty to borrow from the Loan Commis-

sioners (hereinafter referred to as "the Lender") the sum of nine thousand pounds (£9,000) at a rate of interest of four per centum (4%) per annum, subject to the following terms and conditions, that is to say:—

- (a) the sum borrowed shall be repayable by the Municipal Commission to the Lender over a period of twenty years in twenty equal yearly instalments comprising principal and interest, the first instalment to become due and payable one year after the date of borrowing and all subsequent instalments being payable on the corresponding dates in each year following;
- (b) the Municipal Commission shall, in each year and until final repayment of the sum borrowed, insert in the annual estimates as a charge on its revenues the sums payable as aforesaid in the year to which such estimates relate;
- (c) the sum borrowed shall be utilized for the purposes set out in the Schedule to the Order in Council No. 2567 dated the 18th day of October, 1952, published under Notification No. 458 in Supplement No. 3 to the *Gazette* of the 22nd October, 1952, as amended by Order in Council No. 2619 dated the 20th day of May, 1953, published under Notification No. 251 in Supplement No. 3 to the *Gazette* of the 21st May, 1953.

2. For the purpose of securing the repayment of the sum under the loan, the Municipal Commission is hereby authorized, subject to any prior mortgage thereon, to mortgage to the Lender all the rates, fees and duties now payable or hereafter to become payable to the Municipal Commission.
