

sioners (hereinafter referred to as "the Lender") the sum of nine thousand pounds (£9,000) at a rate of interest of four per centum (4%) per annum, subject to the following terms and conditions, that is to say:—

- (a) the sum borrowed shall be repayable by the Municipal Commission to the Lender over a period of twenty years in twenty equal yearly instalments comprising principal and interest, the first instalment to become due and payable one year after the date of borrowing and all subsequent instalments being payable on the corresponding dates in each year following;
- (b) the Municipal Commission shall, in each year and until final repayment of the sum borrowed, insert in the annual estimates as a charge on its revenues the sums payable as aforesaid in the year to which such estimates relate;
- (c) the sum borrowed shall be utilized for the purposes set out in the Schedule to the Order in Council No. 2567 dated the 18th day of October, 1952, published under Notification No. 458 in Supplement No. 3 to the *Gazette* of the 22nd October, 1952, as amended by Order in Council No. 2619 dated the 20th day of May, 1953, published under Notification No. 251 in Supplement No. 3 to the *Gazette* of the 21st May, 1953.

2. For the purpose of securing the repayment of the sum under the loan, the Municipal Commission is hereby authorized, subject to any prior mortgage thereon, to mortgage to the Lender all the rates, fees and duties now payable or hereafter to become payable to the Municipal Commission.

In exercise of the powers vested in me by sub-section (1) of section 210 of the Municipal Corporations Law, I, the Governor, do hereby order as follows:—

1. This Order may be cited as the Municipal Elections (Closing of Licensed Premises) (Rural Municipalities) Order, 1953.

2. In this Order—

“licensed premises” means any premises licensed for the sale of intoxicating liquors by retail under the provisions of the Sale of Intoxicating Liquors Law.

3. Notwithstanding anything contained in the Sale of Intoxicating Liquors (Retailers Closing Hours) Orders, 1952 and 1953, all licensed premises, except clubs if intoxicating liquors are not sold therein, situated within the municipal limits of the rural municipalities specified in the first column of the Schedule hereto shall, during the dates and hours specified in the second column of the said Schedule, be closed and remain closed.
