REGULATIONS MADE UNDER SECTION 8.

A. B. WRIGHT,
Governor.

In exercise of the powers vested in me by section 8 of the Post Office Law, I, the Governor, do hereby make the following regulations:—

1. These regulations may be cited as the Post Office (Insurance of Letters, Boxes and Parcels) (Amendment) Regulations, 1953, and shall be read as one with the Post Office (Insurance of Letters, Boxes and Parcels) Regulations, 1942 and 1952 (hereinafter referred to as "the principal Regulations"), and the principal Regulations and these regulations may together be cited as the Post Office (Insurance of Letters, Boxes and Parcels) Regulations, 1942 to 1953. *Gazettes: Suppl. No 3: 4.5.1942 6.4.1952.*

2. Regulation 5 of the principal Regulations is hereby amended by the insertion therein immediately after the word "Prodhromes" (line 4) of the word "Rizokarpaso".

3. These regulations shall come into operation on the 4th day of June, 1953.

THE DEFENCE (IMPORTATION OF GOODS) REGULATIONS,
1943 TO 1948.

AMENDMENT OF OPEN GENERAL IMPORT LICENCE No. 172801.

In exercise of the powers vested in me by virtue of the Defence (Importation of Goods) Regulations, 1943 to 1948, and of every other power thereunto enabling, I hereby amend the Open General Import Licence No. 172801 published under Notification No. 96 in Supplement No. 3 to the *Gazette* of the 16th March, 1950 (as amended by Notification No. 248 published in Supplement No. 3 to the *Gazette* of the 6th July, 1950) by the deletion from the Schedule thereto of the following items:—

2. Butter: common and table;
9. Commercial Motor Vehicles;
12. Timber of all kinds, whether ready cut or otherwise;
14. Whisky.
