

No. 320. THE MUNICIPAL CORPORATIONS LAW.

CAP. 252 AND LAWS II OF 1950, 31 OF 1951 AND 20 OF 1953.

BYE-LAWS MADE BY THE COUNCIL OF THE MUNICIPAL CORPORATION OF LARNACA.

In exercise of the powers vested in them by the Municipal Corporations Law and otherwise, the Council of the Municipal Corporation of Larnaca hereby make the following bye-laws :—

1. These bye-laws may be cited as the Larnaca Municipal (Amendment) Bye-laws, 1953, and shall be read as one with the Larnaca Municipal Bye-laws, 1949 (hereinafter referred to as "the principal Bye-laws"), and the principal Bye-laws and these bye-laws may together be cited as the Larnaca Municipal Bye-laws, 1949 and 1953.

2. Bye-law 52 of the principal Bye-laws is hereby amended by the insertion therein immediately after the word "slaughter-houses", which occurs at the end thereof, of the words "or at the Government Animal Quarantine Station".

3. Bye-law 53 of the principal Bye-laws is hereby amended by the insertion therein immediately after the word "slaughter-houses", which occurs at the end thereof, of the words "or at the Government Animal Quarantine Station".

4. Bye-law 67 of the principal Bye-laws is hereby amended by the insertion therein immediately after the word "slaughter-houses", which occurs in the first line thereof, of the words "or in the Government Animal Quarantine Station".

5. Bye-law 71 of the principal Bye-laws is hereby amended by the addition at the end thereof of the following proviso :—

"Provided that the Mayor may, in the case of any animal imported into the Colony, permit the slaughter and cleaning of such animal at the premises used as a Government Animal Quarantine Station, and provided that the meat of such animal is sealed with the seal of such Quarantine Station".

6. Paragraph (1) of bye-law 74 of the principal Bye-laws is hereby amended by the insertion therein immediately after the word "slaughter-houses", which occurs in the second line thereof, of the words "or in the Government Animal Quarantine Station".

7. The Third Schedule to the principal Bye-laws is hereby amended as follows :—

(a) by the insertion therein immediately after item 12 thereof, in the respective columns, of the following new item :—

Item No.	Goods.	Minimum weight. (okes)	Fees.
12A.	Cotton, ginned ..	20	3 paras per oke." ;

(b) by the insertion therein immediately after item 26 thereof, in the respective columns, of the following new item :—

Item No.	Goods.	Minimum weight. (okes)	Fees.
26A.	Limestone, whether in its natural state, or cut in pieces, or ground	40	6 piastres per ton."

The above Bye-laws have been approved by His Excellency the Governor.
