THE POST OFFICE LAW.  
CAP. 281.

ORDER IN COUNCIL No. 2630

MADE UNDER SECTION 7.

In exercise of the powers vested in me by section 7 of the Post Office Law, I, the Acting Governor, with the advice of the Executive Council, do hereby order as follows :—

1. This Order may be cited as the Post Office (Rates of Postage and Postal Charges) (Amendment) Order, 1953, and shall be read as one with

the Post Office (Rates of Postage and Postal Charges) Order, 1950 (hereinafter referred to as "the principal Order") and the principal Order and this Order may together be cited as the Post Office (Rates of Postage and Postal Charges) Orders, 1950 to 1953.

2. Part I of the Schedule to the principal Order is hereby amended by the deletion from paragraph 2 thereof under the heading "TO FOREIGN COUNTRIES" of the entry relating to (f) "Literature for the Blind" and the substitution therefor of the following entry:—

(f) <i>Literature for the Blind</i> :	<i>Piastres.</i>
For every 2 lbs. or fraction thereof .. .. .	0 $\frac{1}{4}$

This Order shall come into operation on the 9th day of July, 1953.

**No. 330.** THE PRESS LAWS, 1947 AND 1951.

**No. 331.** THE LAND ACQUISITION LAW.
