**DECLARATION UNDER SECTION 34 (1).**

Whereas the Governing Body of the Turkish Secondary School, Paphos (hereinafter referred to as "the School"), being a secondary school to which section 24 of the Secondary Education Law (hereinafter referred to as "the Law") is applicable, has applied to the Governor for the declaration of the School to be a Public-aided Secondary School :

Now, therefore, in exercise of the powers vested in me by section 34 (1) of the Law, I, the Governor, hereby declare the School to be a Public-aided Secondary School.

2. This declaration shall be deemed to have been made on the 1st day of September, 1953.
