No. 558. THE CONTAGIOUS DISEASES (ANIMALS) LAW.

CAP. 65.

ORDER MADE UNDER SECTION 4 (1) (m).

In exercise of the powers vested in me by paragraph (m) of sub-section (1) of section 4 of the Contagious Diseases (Animals) Law, I, the Governor, Cap. 65. do hereby charge—

(a) all members of the Police Force ;

(b) such officers of the Veterinary Service (Department of Agriculture) as may be authorized in writing by the Chief Veterinary Officer for the purpose,

with the execution of all the provisions and orders which have been made or may, hereafter, be made by virtue of the aforesaid Law.

No. 559. THE ADULTERATION OF PRODUCE LAW.

CAP. 34.

REGULATIONS MADE UNDER SECTION 10.

In exercise of the powers vested in me by section 10 of the Adulteration of Produce Law, I, the Governor, with the advice of the Executive Council, Cap. 34. do hereby make the following regulations :—

1. These Regulations may be cited as the Adulteration of Produce (Amendment) Regulations, 1953, and shall be read as one with the Adulteration of Produce Regulations, 1935 and 1945 (hereinafter referred to as "the principal Regulations"), and the principal Regulations and these Regulations may together be cited as the Adulteration of Produce Regulations, 1935 to 1953.

2. Regulation 2 of the principal Regulations is hereby amended by the addition thereto of the following proviso :—

“ Provided that the Director of Agriculture may, for special reasons, in his discretion and subject to such conditions as he may deem fit to impose, permit the export for industrial purposes of any produce enumerated in the Schedule hereto which contains foreign, superfluous or inferior substance, matter or thing in excess of the percentage prescribed in the said Schedule ”.

NOTIFICATION UNDER SECTION 36 (4).

Whereas by Notice published under No. 362 in Supplement No. 3 to the *Gazette* of the 30th July, 1953, the Commissioner, Nicosia and Kyrenia, has given notice that an area of privately-owned immovable property was required by the Improvement Area of Palouriotissa for the purpose of erecting thereon a public market ;

And whereas at the expiration of the period set out in the said Notice the Commissioner, Nicosia and Kyrenia, has forwarded to the Governor all the required documents ;

And whereas I consider it expedient, having regard to all circumstances, that the said Board should be permitted to acquire the immovable property as required :

Now, therefore, I, the Governor, in exercise of the powers vested in me by section 36 (4) of the Villages (Administration and Improvement) Laws, 1950 and 1953, do hereby sanction the acquisition of the immovable property as required and as set out in the Schedule hereto.

All that area of privately-owned immovable property situated at Palouriotissa village, in the District of Nicosia, including the building-sites under plots Nos. 228 and 229 of Block “ A ”, Palouriotissa Village, comprising 3 evleks and 520 sq. ft. or thereabouts.
