These rules may be cited as the Irrigation Division of Milikouri "Potamos tou Katsoura" and "Potamos tou Choriou" (Amendment) Rules, 1953, and shall be read as one with the Irrigation Division of Milikouri "Potamos tou Katsoura" and "Potamos tou Choriou" Rules, 1952 (hereinafter referred to as "the principal Rules") and the principal Rules and these rules may together be cited as the Irrigation Division of Milikouri "Potamos tou Katsoura" and "Potamos tou Choriou" Rules, 1952 to 1953.
