**THE PORT WORKERS (REGULATION OF EMPLOYMENT)
LAW, 1952.**

ORDER MADE UNDER SECTION 3
AND
CONSTITUTION OF BOARDS UNDER SECTION 4.

Whereas it appears to me that the conditions of employment and other prevailing circumstances in the ports of Limassol, Famagusta and Larnaca are such as to render necessary or expedient the regulation of engagement and employment of port workers therein;

And whereas public interest so requires:

Now, therefore, in exercise of the powers vested in me by sections 3 and 4 of the Port Workers (Regulation of Employment) Law, 1952, I, the Governor, do hereby order as follows:—

1. This Order may be cited as the Port Workers (Limassol, Famagusta and Larnaca) (Regulation of Employment) Order, 1953.

2. In this Order—

“Law” means the Port Workers (Regulation of Employment) Law, 1952;

“ports” mean the ports of Limassol, Famagusta and Larnaca.

3. The provisions of the Law shall as from the 12th day of January, 1953, apply to the ports.

4. There are hereby established in respect of each of the ports a Port Labour Board bearing the name of “Port Labour Board of Limassol” or “Port Labour Board of Famagusta” or “Port Labour Board of Larnaca”, as the case may be, for the purposes of exercising the powers and performing the duties provided in the Law and the Port Workers (Regulation of Employment) Regulations, 1952.

5. The Boards established under clause 4 hereof shall consist of the persons whose names appear in the first column of the Schedule hereto, in the capacities therein appearing, in respect of such port as is set out in the second column of that Schedule against their names.
