THE STREETS AND BUILDINGS REGULATION LAW.  
CAP. 165 AND LAW 10 OF 1950.

DETERMINATION OF APPOINTMENT OF APPROPRIATE AUTHORITY FOR THE  
AREA OF THE EPISCOPI CANTONMENT, UNDER SECTION 3 (2) (b).

Whereas in exercise of the powers vested in him by paragraph (b) of section 3 (2) of the Streets and Buildings Regulation Law the then Acting Governor has been pleased to appoint by a Notification published under No. 433 in Supplement No. 3 to the *Gazette* of the 10th September, 1953, (hereinafter referred to as "the Notification") as appropriate authority for the area set out in the First Schedule thereto a Board consisting of the persons set out in the Second Schedule thereto ;

THE CUSTOMS LAW.

CAP. 292 AND LAWS 5 OF 1952, 19 OF 1953 AND 27 OF 1953.

REGULATIONS MADE UNDER SECTION 61.

In exercise of the powers conferred upon him by section 61 of the Customs Law, His Excellency the Governor, with the advice of the Executive Council, has been pleased to make the following Regulations :—

1. These Regulations may be cited as the Customs Drawback (Paper for the Manufacture of Toilet Paper Rolls) Regulations, 1954.

2. A drawback of import duty at the rate as in these Regulations provided shall be granted, paid and allowed in respect of paper (excluding carton

and paper used for wrapping) imported into the Colony, used therein in the manufacture of toilet paper rolls, and exported therefrom in that form by the manufacturer thereof.

3. The drawback shall be at the full rate of import duty, which the Comptroller is satisfied has been paid on such paper.

4. No claim for drawback shall be admissible for any less sum than £2 for any one consignment.

5. Any person or firm claiming any drawback under these Regulations shall execute a declaration in such form as the Comptroller may from time to time approve, and shall be bound to produce such evidence as the Comptroller may deem necessary to prove the correctness of such declaration or any of the details thereof.

**No. 430.** ✓ **THE SALE OF INTOXICATING LIQUORS LAW.**  
CAP. 152 AND LAW 15 OF 1954.

ORDER MADE UNDER SECTION 8 (1).

In exercise of the powers conferred upon him by section 8 (1) of the Sale of Intoxicating Liquors Law, His Excellency the Governor has been pleased to order as follows:—

1. This Order may be cited as the Sale of Intoxicating Liquors (Retailers Closing Hours) Order, 1954, and shall be read as one with the Sale of Intoxicating Liquors (Retailers Closing Hours) Orders, 1952 and 1953 (hereinafter referred to as the "principal Orders"), and the principal Orders and this Order may together be cited as the Sale of Intoxicating Liquors (Retailers Closing Hours) Orders, 1952 to 1954.

2. The definition of the word "town" in clause 2 of the principal Orders is hereby amended by the insertion therein immediately after the words "in the district of Larnaca" (line 4 thereof) of the words "Lefkoniko in the district of Famagusta".
