

No. 702. THE TREE PLANTING (VILLAGE AREAS) LAW.
CAP. 175.

ORDER UNDER SECTION 12.

Whereas at a meeting duly convened and held at the village of Lefkoniko in the District of Famagusta on the 11th July, 1954, under the provisions of the Tree Planting (Village Areas) Law, it was determined by the requisite majority of the owners present thereat that certain areas should be reserved as a Tree Planting Area of the said village of Lefkoniko :

And whereas the Mukhtar of the said village of Lefkoniko has forwarded to me a report signed and sealed by him containing a description of the areas in question with boundaries and particulars and stating that such areas fulfil the conditions prescribed in section 10 (4) of the said Law :

Now, therefore, I, the Commissioner of the District of Famagusta, having approved the said report, do by this Order declare that the areas described in the Schedule hereto shall be reserved as the Tree Planting Area of the village of Lefkoniko.

SCHEDULE.

The area lying within the following boundaries, that is to say :—

The boundary commences at the north-eastern corner of plot No. 318 of the Government Survey Plan No. XIV.29, locality "Koutsoura", which corner is on the boundary of Lefkoniko village, and proceeds north-eastwards and south-eastwards along the said boundary to the most southern point of plot No. 98 of the Government Survey Plan No. XIV.38, which point is on a track leading from the village of Lefkoniko to the village of Ayios Iakovos ; thence north-westwards and south-westwards along the said track to the most southern point of plot No. 204 of the Government Survey Plan No. XIV.37, locality "Vroundoushia" ; thence southwards, south-westwards, southwards and westwards along the boundaries of and including plot Nos. 219, 217, 247, 265, 245, 243, 241, 242, 270, 268 and 272 of the said plan, plot Nos. 178, 179, 180, 177, 173, 168, 150, 155 and 311 of the Government Survey Plan No. XIV.45, plot Nos. 132, 131, 315, 472 (part) and 318 of the Government Survey Plan No. XIV.45, to the south-western corner of the last mentioned plot, which corner is on a track leading from the village of Lefkoniko to the village of Platani ; thence south-eastwards along the said track to its junction with another track leading from the village of Lefkoniko to the village of Ayios Iakovos ; thence south-westwards along the said track to the most southern point of plot No. 62 of the Government Survey Plan No. XIV.61, locality "Mallies" ; thence north-westwards along the boundaries of and including the last mentioned plot, plot Nos. 61 and 57 of the said plan, plot No. 657 of the Government Survey Plan No. XIV.60, plot No. 4 and 3 of the Government Survey Plan No. XIV.61, plot Nos. 654, 652, 651 and 649 of the Government Survey Plan No. XIV.60, plot Nos. 726, 412, 414, 744, 423, and 436 of the Government Survey Plan No. XIV.52, to the south-western corner of the last mentioned plot, which corner is on the Lefkoniko-Akanthou main road ; thence northwards along the said main road to the most eastern point of plot No. 287 of the Government Survey Plan No. XIV.36, locality "Phtirkaris" ; thence north-eastwards along the boundaries of and including the last mentioned plot, plot Nos. 285, 153, 155, 157, 160, 158, 159, 168, 210, 207, 211 and 202 of the said plan ; plot Nos. 435, 4, 8, 9, 12, and 11 of the Government Survey Plan No. XIV.37, plot Nos. 321, 323.3 and 318 of the Government Survey Plan No. XIV.29, to the point of commencement, all which said boundary is shown edged red on the Government Survey Plan Serial No. 1625 and surrounds an area of 9102 donums or thereabouts.
