In exercise of the powers vested in them by section 124 (n) (i) of the Municipal Corporations Law and of every power thereto enabling, the Council of the Municipal Corporation of Larnaca hereby make the following bye-laws :—

1. These Bye-laws may be cited as the Municipal Corporation (Larnaca) (Amendment) Bye-laws, 1955, and shall be read as one with the Municipal Corporation (Larnaca) Bye-laws, 1949 to 1953 (hereinafter referred to as the "principal Bye-laws") and the principal Bye-laws and these bye-laws may together be cited as the Municipal Corporation (Larnaca) Bye-laws, 1949 to 1955.

2. The Second Schedule (Bye-law 149) to the principal Bye-laws (as set out in the Larnaca Municipal Bye-laws, 1949) is hereby repealed and substituted by the following :—

- "(i) On each ticket the total price of which does not exceed 2 piastres 0½p.
(ii) On each ticket the total price of which exceeds 2 piastres but does not exceed 6 piastres 1½p.
(iii) On each ticket the total price of which exceeds 6 piastres but does not exceed 1 shilling 2p.
(iv) On each ticket the total price of which exceeds 1 shilling but does not exceed 2 shillings 4p.
(v) On each ticket the total price of which exceeds 2 shillings but does not exceed 3 shillings 5p.
(vi) On each ticket the total price of which exceeds 3 shillings but does not exceed 4 shillings 6p.
(vii) On each ticket the total price of which exceeds 4 shillings, a fee of 2 piastres on each additional shilling or part thereof."

These Bye-laws have been approved by His Excellency the Governor.

In exercise of the powers vested in them by section 123 (ce) of the Municipal Corporations Law and of every power thereto enabling, the Council of the Municipal Corporation of Larnaca hereby make the following bye-laws :—

1. These bye-laws may be cited as the Larnaca Municipal (Traffic) (Amendment) Bye-laws, 1955, and shall be read as one with the Larnaca Municipal (Traffic) Bye-laws, 1952 (hereinafter referred to as the "principal Bye-laws") and the principal Bye-laws and these bye-laws may together be cited as the Larnaca Municipal (Traffic) Bye-laws, 1952 and 1955.

2. Bye-law 13 is hereby amended by the insertion after paragraph 2 of the following new paragraph 3 :—

“ On or after the 1st June, 1955, no person shall use, cause, suffer or permit a vehicle to be used in any street, or shall drive or have charge or control of any vehicle the wheels of which are not protected by a rubber cover ”.

THE VILLAGES (ADMINISTRATION AND IMPROVEMENT)
LAWS, 1950 AND 1953.

BYE-LAWS MADE BY THE IMPROVEMENT BOARD OF ASHA.

In exercise of the powers vested in them by section 24 of the Villages (Administration and Improvement) Laws, 1950 and 1953, the Improvement Board of Asha hereby make the following bye-laws :—

1. These bye-laws may be cited as the Villages (Administration and Improvement) Asha (Amendment) Bye-laws, 1955, and shall be read as one with the Villages (Administration and Improvement) Asha Bye-laws, 1951 (hereinafter referred to as “ the principal Bye-laws ”) and the principal Bye-laws and these bye-laws may together be cited as the Villages (Administration and Improvement) Asha Bye-laws, 1951 and 1955.

2. The Third Appendix to the principal Bye-laws is hereby amended by the deletion therefrom of the words “ 191 to 215 (both inclusive) ” and the substitution therefor of the words “ 191 to 195 (both inclusive) ”.

3. Item 49 of the Second Schedule to the principal Bye-laws is hereby amended by the deletion of figure 1 under the column “ Fees for any quantity in excess of the minimum weight. Paras per oke or part thereof ” and the substitution therefor of the figure 2.

The above bye-laws have been approved by the Colonial Secretary.

THE IRRIGATION DIVISIONS (VILLAGES) LAW.
CAP. III.

In pursuance of the provisions of section 19 of the Irrigation Divisions (Villages) Law, the following rules made by the Committee of the Irrigation Division of Ayia Marina Xyliatou, in the District of Nicosia, are published in the *Gazette*.

IRRIGATION DIVISION OF AYIA MARINA XYLIATOU.

Rules.

1. These rules may be cited as the Irrigation Division of Ayia Marina Xyliatou (Amendment) Rules, 1955, and shall be read as one with the Irrigation Division of Ayia Marina Xyliatou Rules, 1944 (hereinafter referred to as “ the principal Rules ”) and the principal Rules and these rules may together be cited as the Irrigation Division of Ayia Marina Xyliatou Rules, 1944 and 1955.

2. Paragraph (2) of rule 4 of the principal Rules is hereby amended by the deletion therefrom of the words “ 1st August ” and the substitution therefor of the words “ 1st November ”.

3. Rule 6 of the principal Rules is hereby amended by the deletion therefrom of the words “ 31st July ” and the substitution therefor of the words “ 31st October ”.

4. Rule 8 of the principal Rules is hereby amended by the deletion therefrom of the words “ 1st day of October ” and the substitution therefor of the words “ 30th day of November ”.
