2. Rule 7 of the principal Rules is hereby repealed and the following rule substituted therefor :—

"Every proprietor mentioned in the list shall pay a charge not exceeding eighty shillings per annum as may be determined by the Committee from time to time for each hour of water of which he is a proprietor".
