**No. 507. THE LAND ACQUISITION LAW.  
CAP. 233 AND LAW 26 OF 1952.**

NOTICE UNDER SECTION 7.

Whereas by Notification published under No. 393 in Supplement No. 3 to the *Gazette* of the 30th June, 1955, the Governor declared under sections 2, 3 and 5 of the Land Acquisition Law the establishment of the Famagusta Cantonment, within the town of Famagusta, to be an undertaking of public utility ;

And whereas the Commissioner, Famagusta, by a notice published under Notification No. 394 in Supplement No. 3 to the *Gazette* of the 30th June, 1955, gave particulars of the properties (hereinafter referred to as "the properties") required in connection with the aforesaid undertaking ;

And whereas the Commissioner, Famagusta, forwarded to the Acting Governor the required recommendations, plans and particulars, together with the objections made ;

And whereas I, the Acting Governor, have approved the plan and particulars submitted, and have considered it expedient, having regard to the circumstances of the case, that only that part of the properties described in the Schedule hereto should be acquired :

Now, therefore, in exercise of the powers vested in me by section 7 of the Land Acquisition Law, I, the Acting Governor, do hereby sanction the acquisition, under the provisions of the said Law, of that part of the properties described in the Schedule hereto.

SCHEDULE.

All those areas of privately owned lands situated at Ayios Loukas Quarter, Famagusta Town, comprising 496 donums or thereabouts and including part of plot No. 5, plots Nos. 4, 406, 108, 407, 408, 409, 410, 411, 412, 413, 414, 415, 416, 417, 418, 419, 420, 421, 422, 423, 424, 326, 327, 328, 329, 330, 342, 402, 403, 443, 444, 331, 427, 428, 336, 335, 334, 341, 340, 400, 401, 338, 43, 44, 45, 46, 47, 48, 49, 52, 53, 54, part of plot No. 55, plot No. 171, part of plots Nos. 172 and 98 of Block D, Ayios Loukas Quarter, Famagusta, plot No. 28 and part of plot No. 400 of Block C, Ayios Loukas Quarter, Famagusta, more particularly defined as the area coloured red on the plan signed by the Assistant Director of Hirings, Cyprus, and dated the 8th August, 1955.
