No. 57. THE PUBLIC HEALTH (VILLAGES) LAW.

CAP. 142.

RULES MADE BY THE VILLAGE HEALTH COMMISSION OF ODHOU IN THE DISTRICT OF LARNACA UNDER SECTION 9.

In exercise of the powers vested in them by section 9 of the Public Health (Villages) Law, the Village Health Commission of Odhou hereby make the following rules :—

1. These rules may be cited as the Village Health (Odhou) Rules, 1955, and shall come into operation on their publication in the *Gazette*.

2.—(1) Subject to the provisions of paragraphs (2) and (3) of this rule, the Village Health (Nikos) Rules, 1952, published in Supplement No. 3 to the *Gazette* of the 19th November, 1952, shall—

(a) be deemed to be rules made by the Village Health Commission of Odhou and to be incorporated herein ; and

(b) apply to the village of Odhou: Provided that for the word "Nikos" and for the word "Nicosia" whenever they occur in the model Rules, the word "Odhou" and the word "Larnaca" shall be substituted respectively.

(2) The rules set out in Part I of the Schedule hereto shall be substituted for the corresponding rules of the Village Health (Nikos) Rules, 1952.

(3) Those rules of the Village Health (Nikos) Rules, 1952, mentioned in Part II of the Schedule hereto, shall not apply to the village of Odhou.

Rule 19. The following fees shall be paid by the owner of or the person slaughtering any animal in the slaughter-house, that is to say :—

(a) For every bullock, camel, cow or ox 3s.

(b) For every goat, kid, lamb or sheep 1s.

(c) For every swine 2s.

Rule 31. The following fees shall be paid by every person exposing for sale any perishable goods in the market of perishable goods, that is to say :—

(a) For perishable goods valued up to 5/- 2p.

(b) For perishable goods valued between 5/- to 10/- 4p.

(c) For perishable goods valued 10/- and over 6p.

Rule 45.—(1) The following fees shall be paid by every person exposing for sale fresh meat in the meat market, that is to say :—

(a) For every carcass of sheep or goat or part thereof	1	0
(b) For every carcass of a young lamb or kid or part thereof	—	6
(c) For every carcass of ox, camel, cow or bullock or part thereof	2	0

Rule 64. The following fees shall be paid by every person selling or exposing for sale in the fair market the following animals, goods, articles, things, eatables or liquids of any kind, that is to say :—

(a) For every camel, horse, mule or ox sold 1s.

(b) For every donkey sold 1s.

(c) For every swine of any age sold 6p.

(d) For any kind of goods, articles, things, eatables or liquids exposed for sale for the whole or any part of the period of the said fair, a fee from one piastre to 1 shilling according to the value or quantity thereof, to be determined in each case by the inspector.
