

No. 1036. THE LAND ACQUISITION LAW.
CAP. 233 AND LAWS 26 OF 1952 AND 43 OF 1955.

NOTICE UNDER SECTIONS 2, 3 AND 5.

Whereas it has been represented to His Excellency the Governor that it is desirable in the public interest to widen, improve and realign the public road between Nicosia and Larnaca by stages as may from time to time be decided (hereinafter referred to as the "road"):

Now, therefore, in exercise of the powers vested in him by sections 2, 3 and 5 of the Land Acquisition Law, His Excellency the Governor does hereby declare the widening, improving and realigning of the road to be an undertaking of public utility, and does hereby authorize the carrying out of the said undertaking under the provisions of the said Law, and does hereby entrust the supervision and effectuation of the said undertaking to the Director of Public Works.

No. 1037. THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)
REGULATIONS, 1955 TO (No. 12) 1956.

ORDER MADE UNDER REGULATION 34 (1) (b).

In exercise of the powers vested in the Governor under Regulation 34 (1) (b) of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 12) 1956, and delegated to me by Notification No. 807 published in Supplement No. 3 to the *Gazette* of the 22nd December, 1955, I, Warren Frederick Martin Clemens, Commissioner of Nicosia and Kyrenia, hereby prohibit the use and circulation of all public omnibuses in Nicosia and Kyrenia District as from 04.00 hours to 14.00 hours on Sunday, 28th October, 1956.

No. 1038. THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)
REGULATIONS, 1955 TO (No. 12) 1956.

ORDER MADE UNDER REGULATION 34 (1) (b).

In exercise of the powers vested in the Governor under paragraph 34 (1) (b) of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 12) 1956, and delegated to me by Notification No. 807 published in Supplement No. 3 to the *Gazette* of the 22nd December, 1955, I, the Commissioner of Famagusta, hereby prohibit the use of motor cycles and bicycles within the Municipal limits of Famagusta between the hours 2 p.m. on Saturday 27th of October until 4 a.m. Monday 29th of October.

My Order dated 28th May, 1956, published under Notification No. 491 in Supplement No. 3 to the *Gazette* No. 3951 of the 7th of June, 1956, is hereby cancelled.
