**THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)
REGULATIONS, 1955 TO (No. 12) 1956.**

ORDER MADE UNDER REGULATION 44.

In exercise of the powers vested in His Excellency the Governor by Regulation 44 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 12) 1956, and delegated to me by Notification No. 736 published in Supplement No. 3 to the *Gazette* of 26th November, 1955, I, Warren Frederick Martin Clemens, Commissioner of Nicosia and Kyrenia, do hereby give notice that in the interests of public order and safety and for maintaining supplies and services essential to the life of the Community have taken possession with immediate effect of the land specified in the Schedule hereto until further notice.

2. The use of the said land as an annex to the General Post Office is hereby authorised.

3. The Authority using the land in pursuance of this order is entitled to do thereon or in relation thereto such acts as may be necessary for the purpose of their occupation.

4. The exercise of any right of way over the land and of any other right relating thereto which is enjoyed by any person, whether by virtue of an interest in the land or otherwise is hereby prohibited during the period this order shall remain in force.

SCHEDULE.

The ground floor entrance and all appurtenances thereto and the first floor buildings of the property situate at No. 9, Medjidie Street, Nicosia, owned under plots Nos. 124 and the parts on 124/2, 124/3, 124/4, 124/5 and 124/6 of Sheet/Plan Nos. XXI.46.2, VIII and XII, Ibrahim Pasha Quarter, Nicosia, more particularly defined as the area coloured red on the plan signed by the Commissioner, Nicosia, dated 31st October, 1956, and deposited in his Office in Nicosia.
