## ORDER MADE UNDER SECTION 2.

In exercise of the powers vested in the Governor by section 2 of the Curfews Laws, 1955, and delegated to me under section 2A of the said Laws by Notification No. 666 published in Supplement No. 3 to the *Gazette* of the 19th July, 1956, I do hereby order as follows :—

1. This Order may be cited as the Curfews (Limassol District No. 25) Order, 1956.

2. Within the area prescribed in the First Schedule hereto no person shall be out of doors between the hours prescribed in the Second Schedule hereto except under the authority of a written permit granted by the Commissioner of Limassol or the Assistant Commissioner of Police in charge of the area :

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces, or the Cyprus Police Force.

This Order shall come into force on the 3rd day of November, 1956.

Within the Municipal boundaries of Limassol town.

## SECOND SCHEDULE.

From 5.30 p.m. on Saturday the 3rd November, 1956, until 5 a.m. on Sunday the 4th November, 1956, and from 5.30 p.m. on Sunday the 4th November, 1956, until 5 a.m. on Monday the 5th November, 1956.

## ORDER MADE UNDER SECTION 2.

In exercise of the powers vested in the Governor by section 2 of the Curfews Laws, 1955, and delegated to me under section 2A of the said Laws by Notification No. 666 published in Supplement No. 3 to the *Gazette* of the 19th July, 1956, I do hereby order as follows :—

1. This Order may be cited as the Curfews (Kyrenia District No. K28) Order, 1956.

2. No person within the areas prescribed in the Schedule hereto shall be out of doors between the hours of 17.30 and 05.00 daily until further notice, except under the authority of a written permit granted by the Assistant Commissioner of Kyrenia or the Superintendent of Police in charge of the area :

Provided that this Order shall not apply to any person who is not a Greek Cypriot male born on or after the 1st January, 1930.
