THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS)
(CYPRUS) ORDER, 1946.

ORDER MADE BY A COMPETENT AUTHORITY UNDER DEFENCE REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as Competent Authority for the purposes of Defence Regulation 61 as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946, which continues in force under the Supplies and Services (Continuance) Order, 1953, I hereby order as follows :—

1. This Order may be cited as the Defence (Registration of Importers) (Amendment) Order, 1956, and shall be read as one with the Defence (Registration of Importers) Order, 1956 (hereinafter referred to as "the principal Order") and the principal Order and this Order may together be cited as the Defence (Registration of Importers) Orders, 1956.

2. Clause 5 of the principal Order is hereby amended by the addition at the end thereof of the following second proviso :—

"Provided further that—

- (a) Where a certificate of registration has been issued in the name of a person and application is later made for a new certificate of registration in a name which is substantially similar to that of the person registered but has been altered owing to the addition or deletion of a partner or by the addition of the word 'Limited' or the words 'and Company' or in some other minor respect ; or
 - (b) Where a duplicate certificate of registration is issued upon loss of the original certificate or for any other reason,
- there shall be charged and paid a fee of five hundred mils only."

EXPLANATORY NOTE.

The above Order provides for a reduced fee of 500 mils for a certificate of registration of an importer under the Defence (Registration of Importers) Order in the circumstances set out in the Order. The fee for new registration remains at £5.
