**THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)  
REGULATIONS, 1955 TO (No. 16) 1956.**

**DIRECTIONS MADE UNDER REGULATION 33 (1).**

In exercise of the powers vested in the Governor by Regulation 33 (1) of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 16) 1956, and delegated to me by Notification No. 735 published in Supplement No. 3 to the *Gazette* of the 26th November, 1955, I, the Commissioner of Famagusta, do hereby direct that in order to facilitate the operations of the Cyprus Police Force, the roads in Varosha listed in the first column of the Schedule hereto be closed to all pedestrian and other traffic proceeding from or to the street or plot shown in the second column of the said Schedule until further notice.

**THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)  
REGULATIONS, 1955 TO (No. 16) 1956.**

**ORDER MADE UNDER REGULATION 39 (1) (b).**

In exercise of the powers vested in the Governor under Regulation 34 (1) (b) of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 16) 1956, and delegated to me by Notification No. 807 published in Supplement No. 3 to the *Gazette* of the 22nd December, 1955, I, the Commissioner of Limassol, hereby order that between the hours of 9 a.m. and 1.30 p.m. daily until further notice within the area described in the Schedule hereto—

- (a) no bus or lorry shall circulate or be left stationary on any public street, including sidewalks ; and
- (b) no goods carrying trailer shall circulate or be left stationary on any public street without a permit first obtained from the Commissioner.

2. This Order shall not apply to vehicles of Her Majesty's Forces and of the Cyprus Police Force, or to vehicles carrying Royal Mail when proceeding to and from the Post Office *via* King George VI Street.

3. The Order published under Notification No. 1135 in Supplement No. 3 to the *Gazette* of the 22nd November, 1956, is hereby revoked.

**SCHEDULE.**

The area bounded on the east by Augustas Theodoras Street and Zenonos Street (inclusive), on the north by Gladstone Street and Navarino Street (exclusive) on the west by Eleftheria Street and Victoria Street (inclusive) and on the south by Spyros Araouzos Street and Christodoulou Haggipavlou Street (inclusive).
