THE SOIL CONSERVATION LAWS, 1952 AND 1956.

NOTICE UNDER SECTION 9.

Pursuant to section 9 of the Soil Conservation Laws, 1952 and 1956, it is hereby notified that, with the approval of the Governor, a Soil Conservation Division has been formed in respect of the areas lying within the following boundaries, that is to say :—

Area "A".

All those areas of land at the localities "Kato Ambelia" and "Saittas" in the village of Moniatis, in the District of Limassol, comprising plots Nos. 248, 250/1, 250/2, 249, 228/1, 228/2, 229, 230, 231, 232, 235, 236/1, 236/2, 236/3, 237/1, 237/2, 237/3, 237/4, 237/5, 203/1, 203/2, 203/3, 204, 205, 206/1, 206/2, 207, 198/1, 198/2, 198/3, 200/1 and 200/2 of the Government Survey Plan No. XLVII.21.

Area "B".

All those areas of land at the locality "Saittas" in the village of Moniatis, in the District of Limassol, comprising plots Nos. 220, 217, 217/1, 218, 216, 216/1, 216/2 and 216/3 of the Government Survey Plan No. XLVII.21, plots Nos. 216/4, 40, 41/1, 41/2, 42, 42/2, 43, 43/1, 43/2, 44/2, 44/1/1, 44/1/2, 44/1/3 of the Government Survey Plan No. XLVII.29.

The said areas described in Schedules A and B are more particularly defined as the areas coloured yellow on the Government Survey Plan marked "MONIATIS SOIL CONSERVATION DIVISION" dated the 28th November, 1956, signed by the Acting Director of Agriculture and deposited in his office at Nicosia.

APPENDIX.

It is proposed to improve the existing terraces, to reconstruct most of the existing dry stone walls, and to level about two-thirds of the whole area for bench terracing purposes. Further, ripping, rock-raking and ploughing will be carried out and the irrigation channels will be so arranged as to command the whole area of nearly 100 donums.
