

**No. 1287.** THE LAND ACQUISITION LAW.  
CAP. 233 AND LAWS 26 OF 1952, 43 OF 1955 AND 22 OF 1956.

NOTICE UNDER SECTIONS 2, 3 AND 5.

Whereas it has been represented to His Excellency the Governor that it is desirable in the public interest to carry out certain improvements to the Pedieos bridge and approach roads, Nicosia :

Now, therefore, in exercise of the powers vested in him by sections 2, 3 and 5 of the Land Acquisition Law, His Excellency the Governor does hereby declare the carrying out of the improvements to the said bridge and approach roads and the acquisition of land in connection therewith to be an undertaking of public utility and does hereby authorize the carrying out of the said undertaking, under the provisions of the said Law, and does hereby entrust the supervision and effectuation of the said undertaking to the Director of Public Works.

**No. 1288.** THE CURFEWS LAWS, 1955.  
LAWS 17 AND 47 OF 1955.

ORDER MADE UNDER SECTION 2.

In exercise of the powers vested in the Governor by section 2 of the Curfews Laws, 1955, and delegated to me under section 2A of the said Laws by Notification No. 666 published in Supplement No. 3 to the *Gazette* of the 1st July, 1956, I do hereby order as follows :—

1. This Order may be cited as the Curfews (Nicosia/Kyrenia District No. L.6) Order, 1956.

2. No person within the area specified in the First Schedule hereto shall be out of doors between the hours prescribed in the Second Schedule hereto except under the authority of a written permit granted by the Assistant Commissioner of Lefka or the Superintendent of Police in charge of the area :

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces, or the Cyprus Police Force.

The Order shall come into force on the 11th day of December, 1956.

FIRST SCHEDULE.

That area in the Lefka Sub-District which is bounded on the north side by a straight east-west line from Apliki to Phlevas saw-mill ; and on the west side by the road running south from Phlevas saw-mill to Vroisha village and on to Stavros ; and on the south by the road running from Stavros through Kykko Monastery to Pedhoulas ; and on the east by the road from Pedhoulas to Apliki. The villages of Apliki, Kalopanayiotis, Moutoullas and Pedhoulas are not included in the curfew area.

SECOND SCHEDULE.

From 06.00 hours on eleventh day of December, 1956, until further notice.

Ordered this 11th day of December, 1956.
