

- (b) the person for the time being holding the office of Senior Specialist (Surgeon), for cases falling under general surgery ; and
 (c) the person for the time being holding the office of Senior Specialist (Orthopaedic Surgeon), for cases of an orthopaedic nature.
2. The appointments made under Notification No. 72 published in Supplement No. 3 to the *Gazette* of the 4th February, 1954, and under Notification No. 464 published in Supplement No. 3 to the *Gazette* of the 4th August, 1955, are hereby revoked.

No. 20. **THE LAND ACQUISITION LAW.**
CAP. 233 AND LAW 26 OF 1952.

NOTIFICATION UNDER SECTIONS 2, 3 AND 5.

Whereas it has been represented to the Governor that it is desirable in the public interest to acquire certain lands situated at Knodhara in the District of Famagusta for the purpose of erecting thereon a Moslem Secondary School (Orta Okul) :

Now, therefore, in exercise of the powers vested in the Governor by sections 2, 3 and 5 of the Land Acquisition Law, His Excellency the Governor hereby declares the acquisition of the said lands for the aforesaid purpose to be an undertaking of public utility and does hereby authorise the carrying out of the said undertaking and hereby entrusts the Governing Body for the Moslem Secondary Schools, Famagusta, with the supervision and effectuation of the said undertaking, the cost whereof shall be borne by the Governing Body hereinbefore mentioned.

(The Governing Bodies for the Moslem Secondary Schools have been recognized as public bodies for the purposes of the Land Acquisition Law, under Notification No. 23 published in Supplement No. 3 to the *Gazette* of the 21st January, 1953).

No. 21. **THE LAND ACQUISITION LAW.**
CAP. 233 AND LAW 26 OF 1952.

NOTIFICATION UNDER SECTIONS 2, 3 AND 5.

Whereas it has been represented to His Excellency the Governor that it is desirable in the public interest to establish, within the limits of Strovolos village, a scheme to supply water to the Government quarters in the surrounding areas, in the District of Nicosia :

Now, therefore, in exercise of the powers vested in the Governor by sections 2, 3 and 5 of the Land Acquisition Law, His Excellency the Governor has been pleased to declare the establishment, within the limits of Strovolos village, of the aforesaid scheme to be an undertaking of public utility and hereby authorises the carrying out of the said undertaking and does hereby entrust the supervision and effectuation of the said undertaking to the Director of Water Development.
