

No. 256.**THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)
REGULATIONS, 1955 TO (No. 3) 1956.****ORDER MADE UNDER REGULATION 34 (1) (b).**

In exercise of the powers vested in the Governor under paragraph 34 (1) (b) of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 3) 1956, and delegated to me by Notification No. 807 published in Supplement No. 3 to the *Gazette* of the 22nd December, 1955, I, the Commissioner of Limassol, hereby order that until further notice no motor vehicle shall be left stationary on any public street within the Municipal limits of Limassol without a responsible adult person in constant attendance and control of such vehicle :

Provided that this Order shall not apply to motor cycles.

No. 257. THE SOIL CONSERVATION LAW, 1952.**NOTICE UNDER SECTION 9.**

Pursuant to section 9 of the Soil Conservation Law, 1952, it is hereby notified that, with the approval of the Governor, a Soil Conservation Division has been formed at Galinoporni village in respect of the area lying within the following boundaries that is to say :—

The boundary commences at the north-western corner of plot No. 204 of the Government Survey Plan No. IV.33, locality "Pelenti", and proceeds eastwards along the boundaries of and including the said plot, plots Nos. 205 and 206 of the said plan to the north-eastern corner of the last mentioned plot, which corner is on a track : thence northwards along the eastern side of the said track to a point on the said side, due east of the south-eastern corner of plot No. 157 of the said plan, locality "Loura" ; thence in an easterly and southerly direction along the boundaries of and including plot No. 156 (part) of the said plan, plot No. 2 of the Government Survey Plan No. IV.34, plots Nos. 138 (part) and 143 (part) of the Government Survey Plan No. IV.26, plot No. 8 of the Government Survey Plan No. IV.34, plots Nos. 144 and 145 of the Government Survey Plan No. IV.26, plot No. 32 of the Government Survey Plan No. IV.34, plots Nos. 146, 147, 124, 123, 151, 122 and 152 (part) of the Government Survey Plan No. IV.26, plots Nos. 19 (part), 23 and 22 of the Government Survey Plan No. IV.34 (of Galinoporni village) to the north-western corner of plot No. 203 of the said plan, locality "Korakas" ; thence south-eastwards along the boundaries of and including the last mentioned plot, plots Nos. 204 and 207 of the said plan, plots Nos. 120, 119, 123, 155, 157, 159, 160 (of Rizokarpaso village) 193 (part) and 192 of the Government Survey Plan No. IV.35, plot No. 5 (part) of the Government Survey Plan No. IV.43, plot No. 182 (part) of the Government Survey Plan No. IV.35, plots Nos. 7, 6, 4, 3, 2 and 1 (part) of the Government Survey Plan No. IV.43, plots Nos. 189, 183, 186 and 185 of the Government Survey Plan No. IV.35, plot No. 157 (part) of the Government Survey Plan No. IV.34, plot No. 172 of the Government Survey Plan No. IV.35, plots Nos. 155, 154, 107, 108, 208 (part) (of Rizokarpaso village), 105 (part), 104 (part), 59, 102, 101 (part), 60, 95 (part), 92 (part), 91 (part), 86 (part), 81, 128 (part) 80, 79, 78 and 133 (part) of

the Government Survey Plan No. IV.34, plots Nos. 205, 225, 226, 228, 229, 230 (part), 231 (part), 260, 261, 259, 258, 255 (part) 254 (part), 253, 252 (part), 251 (part), 248 and 240 of the Government Survey Plan No. IV.33, to the most western point of the last mentioned plot, locality "Kerazies"; thence in a north-easterly direction along the boundaries of and including the said plot, plots Nos. 239, 219, (part), 238, 237, 222, 221 (part), 210 (part), 209, 208 (part), 202 and 203 of the said plan, to the point of commencement, all which said area is shown edged in red on the Government Survey Plan signed by the Director of Agriculture, dated the 10th February, 1956, and deposited in his office at Nicosia.

And that the Soil Conservation Scheme briefly set out in the Appendix hereto will be in operation within the aforesaid area.

APPENDIX.

About 120 spillways will be constructed including the old spillways to be reconstructed. At the same time the gullies formed by erosion will be plugged and a good deal of levelling carried out.

THE POLICE LAW.

CAP. 265 AND LAWS 24 OF 1953, 31 OF 1954, 21 OF 1955, 39 OF 1955
AND 48 OF 1955.
