

No. 30. THE LAND ACQUISITION LAW.
CAP. 233 AND LAWS 26 OF 1952 AND 43 OF 1955.

NOTICE UNDER SECTION 7.

Whereas by Notification published under No. 664 in Supplement No. 3 to the *Gazette* of the 25th November, 1954, His Excellency the Governor, declared the carrying out of the Development of the Limassol Port to be an undertaking of public utility ;

And whereas the Commissioner, Limassol, by a notice published under No. 674 in Supplement No. 3 to the *Gazette* of the 25th November, 1954, gave particulars of the properties (hereinafter referred to as "the properties") required in connection with the aforesaid undertaking ;

And whereas the Commissioner forwarded to the Governor the required recommendations, plans and particulars, together with the objections made ;

And whereas His Excellency the Governor has approved the plan and particulars submitted, except in respect of the part of the properties described in the Schedule hereto, and has considered it expedient, having regard for all the circumstances of the case, that the properties should be acquired except the part described in the Schedule hereto ;

Now, therefore, in exercise of the powers vested in him by section 7 of the Land Acquisition Law, His Excellency the Governor, does hereby sanction the acquisition, under the provisions of the said Law, of the properties except the part described in the Schedule hereto.

SCHEDULE.

All those areas of privately-owned lands situated in Limassol Town, being plots Nos. 1 and 2 of Ayios Antonios Quarter, plots Nos. 11/1/1/2, 11/2/2, 11/1/2, part of plots Nos. 11/1/1/1 and 4 of Block 2, Jami Jedid Quarter, more particularly defined as the areas delineated in yellow on the plan marked "DEVELOPMENT OF LIMASSOL PORT" and dated the 7th November, 1955, a copy of which is deposited in the office of the Commissioner, Limassol.

No. 31. THE RENT (CONTROL) LAW, 1954.
LAWS 13 OF 1954 AND 58 OF 1955.

NOTIFICATION UNDER SECTION 10.
