NOTICE UNDER SECTION 6.

With reference to Notification No. 32 published in Supplement No. 3 to the *Gazette* of the 21st January, 1954, notice is hereby given that the following easement is required for the undertaking of public utility mentioned therein, that is to say :—

The laying and maintaining of a pipe-line and electric cables under the privately-owned lands situated in the village of Kolossi, at the localities Phinidji and Phtana tou Phinidjou under plots Nos. 58/26, 58/37, 58/7 and 58 of the Government Survey Plan No. LVIII.14.

The direction of the pipe-line and electric cables is more particularly defined by a red line on the plan marked AKROTIRI AIRFIELD WATER SUPPLY PIPE-LINE, signed by the Assistant Director of Hirings, Cyprus, and dated the 21st December, 1955.

2. Any person claiming to have any right or interest in the said lands who objects to the acquisition is required within ten days from the date of the publication of this notice to send to me a statement of his right and interest and of the evidence thereof, and of any claim made by him in respect of such right or interest.

3. Her Majesty's Secretary of State for Air is willing to treat for the acquisition of the said easement.

4. The plan referred to above is available for inspection at my office.

REGULATIONS MADE BY THE WATER BOARD OF FAMAGUSTA
UNDER SECTION 38.

In exercise of the powers vested in them by section 38 of the Water Supply (Municipal and Other Areas) Laws, 1951 to 1954, the Water Board of Famagusta hereby make the following regulations :—

1. These regulations may be cited as the Famagusta Water Board (Amendment) Regulations, 1956, and shall be read as one with the Famagusta Water Board Regulations, 1952 (hereinafter referred to as "the principal Regulations"), and the principal Regulations and these Regulations may together be cited as the Famagusta Water Board Regulations, 1952 and 1956.

2. Regulation 14 of the principal Regulations is hereby amended by the deletion therefrom of the words "three shillings" (appearing in lines 8 and 9) and the substitution therefor of the words "one pound".

The above Regulations have been approved by the Governor.
