THE MUNICIPAL CORPORATIONS LAW.

CAP. 252 AND LAWS II OF 1950, 31 OF 1951, 20 OF 1953, 29 OF 1954, 57 OF 1954 AND 14 OF 1955.

ORDER IN COUNCIL No. 2823

MADE UNDER SECTION 79.

Whereas at a meeting of the Council of the Municipal Corporation of Famagusta held on the 6th October, 1955, it was decided by the requisite majority of its members—

- (a) to cede to Mr. Mustafa Halil Mulla Hassan of Famagusta the Municipal property described in the First Schedule hereto in exchange for the property described in the Second Schedule hereto ;
- (b) to cede the properties described in the Second and Third Schedules hereto for the opening of a new road to connect the roads known as Elmas Tapia and Altin Tapia in the old town of Famagusta :

Now, therefore, in exercise of the powers vested in him by section 79 of the Municipal Corporations Law, His Excellency the Governor, with the advice of the Executive Council, has been pleased to sanction the disposal of the above property by the Municipal Corporation of Famagusta for the purposes mentioned above.
