THE POST OFFICE LAW.

CAP. 281 AND LAW 44 OF 1953.

ORDER IN COUNCIL No. 2843

MADE UNDER SECTION 7.

In exercise of the powers vested in him by section 7 of the Post Office Law, Cap. 281 His Excellency the Governor, with the advice of the Executive Council, has been pleased to order as follows:—

1. This Order may be cited as the Post Office (Parcels Post Rates of Postage) Order, 1956.

2. The respective rates of postage set forth in the Schedule hereto shall be charged by the Postmaster-General in respect of parcels posted in the Colony for conveyance to places therein mentioned.

3. This Order shall come into operation on the 1st day of July, 1956, and thereupon the Post Office (Parcels Post Rates of Postage) Orders, 1955 and 1956, shall be revoked.

THE STREETS AND BUILDINGS REGULATION LAW.

CAP. 165 AND LAWS 10 OF 1950, 14 OF 1954 AND 18 OF 1955.
